Subtitle of House Bill No. 1021

"TOBACCO SETTLEMENT REVENUE BONDS ACT OF 2006."

Amendment No. 1 to House Bill No. 1021.

Amend House Bill No. 1021 as originally introduced:

Page 1, delete lines 22 through 28 in their entirety and substitute:

"ARKANSAS; TO MAKE AN APPROPRIATION FOR THE ARKANSAS CANCER RESEARCH CENTER ADDITION; AND FOR OTHER PURPOSES."

AND

Page 1 delete the subtitle and substitute the following:

"TO CLARIFY THE DESIGNATION OF THE ARKANSAS CANCER RESEARCH CENTER AS THE OFFICIAL CANCER INSTITUTE OF ARKANSAS AND PROVIDE FUNDING FOR CAPITAL IMPROVEMENTS."

AND

Page 2, delete lines 1 through 7 in their entirety and substitute:

"SECTION 1. Arkansas Code Title 20, Chapter 15 is amended to add the following new subchapter:

20-15-1801. Official Cancer Institute of the State."

AND

Page 2, line 18, delete "1984. It is therefore" and substitute "1984; and"

AND

Page 2, delete lines 19 through 21 in their entirety

AND

Page 2, line 23 delete "facilities by authorizing" and substitute



"facilities."

AND

Page 2, delete lines 24 through 36 in their entirety

AND

Page 3, delete lines 2 through 34 in their entirety

AND

Immediately following SECTION 1 add the following new SECTIONS to read as follows:

"SECTION 2. APPROPRIATIONS - CASH FUNDS - ARKANSAS CANCER RESEARCH CENTER ADDITION. There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from the cash funds as defined by Arkansas Code 19-4-801, the following:

(A) For design, construction, equipping, furnishing and other associated costs for an addition to the Arkansas Cancer Research Center, solely from monies transferred by warrant from unallocated balances of the General Revenue Allotment Reserve Fund, the sum of.....\$35,000,000.

SECTION 3. APPROPRIATION - ARKANSAS CANCER RESEARCH CENTER ADDITION - FUND TRANSFER BY WARRANT. There is hereby appropriated, to the University of Arkansas for Medical Sciences, to be payable from unallocated balances of the General Revenue Allotment Reserve Fund, for transfer by warrant on June 30, 2006, to cash funds as defined by Arkansas Code 19-4-801 of the University of Arkansas for Medical Sciences for the Arkansas Cancer Research Center Addition, for the biennial period ending June 30, 2007, the sum of
.....\$35,000,000."

AND

Renumber the subsequent SECTION numbers of the bill.
