Insert additional SECTIONS immediately following SECTION 86 to read as follows:

“SECTION 87. APPROPRIATIONS – ARKANSAS RAINY DAY FUND. There is hereby appropriated, to the Department of Finance and Administration – Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Arkansas Rainy Day Fund, for the biennial period ending June 30, 2009, the sum of\$125,000,000.

SECTION 88. Uncodified Section 1(A) of Act 1512 of 2005 is amended to read as follows:

(A) For state support ~~to the Washington Regional Hospital for Inpatient Psychiatric Care Services~~, the sum of~~\$97,500~~ 60,000.

SECTION 3. As referenced in Section 3 of Act 2315 of the Regular Session, 85th General Assembly, which identifies the Washington Regional Hospital for Psychiatric Care Services as a project to be funded from the 85th Session Projects Account of the General Improvement Fund, shall instead be deemed to be for Inpatient Psychiatric Care Services.

SECTION 89. REAPPROPRIATION - STATE LIBRARIES GRANTS. There is hereby appropriated, to the Department of Finance and Administration - Disbursing Officer, to be payable from the General Improvement Fund or its successor fund or fund accounts, for the Department of Finance and Administration - Disbursing Officer, the following:

(A) Effective July 1, 2007, the balance of the appropriation provided in Item (A) of Section 1 of Act 932 of 2005 for State assistance to the Cleburne County Library, is hereby deemed and appropriated for state assistance grants to State libraries, in a sum not to exceed.....\$50,000.

SECTION 90. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. STATE LIBRARIES GRANTS FUNDING. The funds received by the Department of Finance and Administration - Disbursing Officer as authorized by Act 2315 of the Regular Session of 2005 for State assistance to the Cleburne County Library shall be transferred to the 86th Session Projects Account to be used exclusively to provide funds for State assistance grants to State libraries authorized by Section 89 of this Act.

The provisions of this section shall be in effect only from July 1, 2007 through June 30, 2009.

SECTION 91. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PULASKI COUNTY DESEGREGATION CASE COSTS - FUND TRANSFERS - EIGHTY-FIFTH SESSION PROJECTS ACCOUNT. (a) On July 1, 2007, the Chief Fiscal Officer of the State shall transfer on his or her books and those of the State Treasurer and the Auditor of State ten thousand dollars (\$10,000), or however much thereof remains, of the funds from the Eighty-Fifth Session Projects Account of the General Improvement Fund, as appropriated in Act 1473 of 2005 for state aid to the Jacksonville Museum of Military History, to the Department of Education Fund Account to provide funds for the Department of Education for payment of consultants, expert witnesses, attorneys' fees, or other costs related to investigating and pursuing the end of the Pulaski County Desegregation Case.

(b) On July 1, 2007, the Chief Fiscal Officer of the State shall transfer on his or her books and those of the State Treasurer and the Auditor of State ten thousand dollars (\$10,000), or however much thereof remains, of the funds from the Eighty-Fifth Session Projects Account of the General Improvement Fund, as appropriated in Act 644 of 2005 for state assistance to the Reed's Bridge Preservation Society, Inc., to the Department of Education Fund Account to provide funds for the Department of Education for payment of consultants, expert witnesses, attorneys' fees, or other costs related to investigating and pursuing the end of the Pulaski County Desegregation Case.

The provisions of this section shall be in effect only from July 1, 2007 through June 30, 2009."

Appropriately renumber the remaining SECTIONS of the bill.
