### Subtitle of Senate Bill No. 227

OF HIGHER EDUCATION; REAPPROPRIATION.

### Amendment No. 1 to Senate Bill No. 227

Amend Senate Bill No. 227 as originally introduced:

Page 11, line 10, following "auditorium" insert ", scholarships, operations, equipment, improvements and renovations"

AND

Following Section 21, insert new sections:

" SECTION 22. Uncodified Section 9(Z) of Act 289 of 2010 is amended to read as follows:

(Z) Effective July 1, 2010, the balance of the appropriation provided in Item (N) of Section 5 of Act 508 of 2009, for construction of an auditorium, scholarships, operations, equipment, improvements and renovations - U of A - Clinton School campus, in a sum not to exceed .....\$100,000.

SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. As referenced in Section 3 of Act 1442 of 2009 and Section 3 of Act 1443 of 2009, the authorized funding for the University of Arkansas for construction of an auditorium - U of A - Clinton School campus shall be deemed to also include scholarships, operations, equipment, improvements and renovations."

AND

Delete Section 24 and insert therefor:

"SECTION 26. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for a longer period than one (1) fiscal year; that the effectiveness of this Act on July 1, 2011 is essential to the operation of the agency for which the appropriations in this Act are provided, with the exception that Sections 22 and 23 in this Act shall be in full force and effect from and after the date of its passage and approval, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2011 could work irreparable harm upon the



proper administration and provision of essential governmental programs, with the exception that Sections 22 and 23 in this Act shall be in full force and effect from and after the date of its passage and approval. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2011, with the exception that Sections 22 and 23 in this Act shall be in full force and effect from and after the date of its passage and approval.”

AND

Appropriately renumber the sections
