Senator Jason Rapert is serving his first term in the Arkansas Senate. Elected in November 2010, he currently represents Senate District 18, which comprises Conway, Perry and Van Buren counties and parts of Cleburne, Faulkner, Pope and Saline counties.

During the 88th General Assembly, he serves as chairman of the Senate Financial Institutions Subcommittee and vice-chairman of Senate Insurance and Commerce.
