Biography of THE HONORABLE BRUCE MALOCH ARKANSAS STATE SENATOR

Arkansas State Senator Bruce Maloch represents Senate District 12, which includes Columbia and Dallas counties and portions of Clark, Grant, Nevada and Ouachita counties. He is serving his first term in the Senate. In the 90th General Assembly, he is chairman of Senate Rules, Resolutions & Memorials and co-chairman of Arkansas Legislative Council (ALC) – Peer Committee. He is vice-chairman of Joint Budget Committee (JBC) – Special Language and ALC-Administrative Rules & Regulations. Senator Maloch's current committee memberships include: Senate Revenue & Tax; Senate Agriculture, Forestry & Economic Development; Arkansas Legislative Council (ALC); Joint Public Retirement & Social Security Programs; Joint Budget Committee (JBC); ALC-Personnel; Economic and Tax Policy; ALC-Lottery Oversight Subcommittee; Arkansas State Game & Fish Commission Oversight Committee and Girls State.

In the 89th General Assembly, Senator Maloch served as chairman of ALC-Peer Committee and the Economic and Tax Policy Committee. He was vice chairman of Senate Agriculture, Forestry & Economic Development and the ALC-Administrative Rules and Regulations Committees. His memberships included Senate Rules, Resolutions & Memorials, Senate Revenue & Tax; Arkansas Legislative Council (ALC); Joint Budget Committee (JBC); Joint Public Retirement & Social Security Programs; ALC-Review and JBC-Review.

Regionally and nationally, Senator Maloch works with legislators from across the nation as a member of the Southern Legislative Conference (SLC), the Council of State Governments (CSG) and the National Conference of State Legislatures (NCSL). He serves on the Agriculture & Rural Development Committee of SLC, the Fiscal and Economic Development/Public Policy Committee of CSG and on the Communications, Financial Services & Interstate Commerce Committee of the NCSL.

Senator Maloch has been involved in public service for decades. In 2004 he was elected to the Arkansas House of Representatives, where he served three consecutive terms. In his first term, he was elected chairman of his 37-member Freshman Caucus. While serving in the House, he was chairman of the Joint Budget Committee, where he helped guide the 87th General Assembly through the state's first Fiscal Session. Maloch was recognized as Legislator of the Year by the Arkansas Realtors Association, Person of the Year by the Arkansas Municipal League and was named one of the state's top 10 legislators by *Talk Business* magazine.

Professionally, Maloch practiced law nearly three years with Anderson, Crumpler, Bell & Maloch before joining Farmers Bank & Trust Co. He is currently the company's Vice Chairman, Chief Operating Officer and General Counsel and is a member of the board of directors.
