#### **PURPOSE:**

To present funding recommendations from AEDC Rural Services for the Arkansas Rural Community Grant Program

#### **BACKGROUND:**

Each fiscal year, AEDC Rural Services receives legislative appropriation to award \$600,000.00 in funding to eligible applicants of the grant program listed above.

# Applications received by AEDC Rural Services go through the following process:

- 1. Reviewed for eligibility by Rural Services staff;
- 2. Eligible applications and rankings are then reviewed by the Rural Development Commission;
- 3. Recommendations are forwarded to the Executive Director of the AEDC; Governor; and
- 4. Recommendations are forwarded to Legislative Council for final approval.

#### PROGRAM OVERVIEW:

 Rural Community Grant Program – Cities and towns with a population of less than 3,000 (no limit on unincorporated areas). Eligible projects include, but are not limited to, community centers, fire stations, parks, storm sirens, storm shelters, beautification projects and any equipment associated.
The cap for this grant program is \$15,000 and requires a 50/50 match from all applicants.

## PROPOSED FUNDING:

- Total amount of funding available for Fiscal Year 2023: \$600,000.00
- Funding previously awarded for Cycle 1 of Fiscal Year 2023: \$277,586.60 (Awarded November 3, 2022)
- Amount requested from recommended applications for Cycle 2 of Fiscal Year 2023: \$339,848.15

Amount of total funding awarded (Cycle 1) and pending funding recommendations (Cycle 2): \$617,434.75

\*(Overage of \$17,434.75 will come from the Division of Rural Services Operations Budget if approved)
