

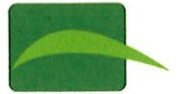

Re: Arkansas Forestry Commission monthly activity report for May 2019

Dear Senator Bledsoe and Representative Wardlaw:

Per Section 42 of Act 841 of the 2017 Regular Session, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for May 2019.

400 firefighter trainees from nineteen states participated in the 2019 Arkansas River Valley Fire Academy at Arkansas Tech University to gain valuable wildland fire training from experienced professionals. The annual two-week event is hosted by the Arkansas Agriculture Department's Arkansas Forestry Commission (AFC), U. S. Forest Service, Arkansas Game and Fish Commission, the National Park Service and many others.

Instructors from the AFC and its partners in wildfire suppression, prescribed fire, and conservation combine hands-on exercises and classroom material to teach basic fire suppression, advanced suppression strategy and tactics, engine operation, dozer operation, Incident Command procedures, and more.

This year showed a significant increase of 150 students. This may qualify Arkansas to host a Regional Academy next year. This will allow for much needed, higher level classes!

May 2019 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During May a total of five wildfires were suppressed for a total of 11 acres burned. The ten-year average for the month of May is 37 wildfires with 366 acres burned.

Search and Rescue Assistance: An AFC crew assisted in a search and rescue for a man whose vehicle was found in War Eagle Creek just west of Highway 23, 1 mile north of Witter, in Madison County. He was found safe on County Road 5120.

Storm Damage Assistance: An AFC crew cleared storm debris from Batesville Pike in the Gibson area in Pulaski County.

Three AFC crews assisted in clearing roads of storm debris on Sugar Road east of Bergman in Boone County.

An AFC crew assisted in clearing roads of storm debris using chainsaws and dozers. They helped clear Wilson and Fryer Bridge Roads southeast of Hattiesville in Conway County.

An AFC crew assisted in clearing roads of storm debris using chainsaws along Highway 23 S in the Ozark area in Franklin County.

An AFC crew assisted in clearing Fly Gap Road of storm debris using chainsaws in Franklin County.

An AFC crew cleared storm debris from roads around the AFC Johnson County work center.

AFC crews are assisting with 24-hour levee patrol in Crawford County due to the flooding of the Arkansas River. AFC airplanes have also been used some for levee patrol in Crawford and Jefferson Counties.

Rural Fire Protection: Rural Fire Protection (RFP) assists fire departments (FDs) with organization, training and equipment. RFP provides interest-free loans, secures firefighting and emergency service equipment from the federal government, and administers a federal grant to assist approximately 1,000 fire departments. The RFP shop provides maintenance to property destined for FD's and repairs AFC equipment.

May 2019

- Four Wildland fire training classes were conducted with eight FDs represented (50-firefighters).
- RFP received four storage containers (valued at \$27,585.96), on boat, trailer and motor (valued at \$9,720.00) and 16-generators (valued at \$398,325.40).
- There was seven Department of Defense (DOD) vehicles issued to FDs, three Freightliners and an AM General (valued at \$460,732.00) and three brush trucks (valued at \$190,374.00).
- 296 DOD Recycling Control Point (RCP) items were received for redistribution to FDs and AFC (valued at \$29,860.79) to include flame resistant undershirts, sun/wind goggles, spill kits and hazmat suits.
- The RFP shop completed maintenance on nine AFC vehicles and equipment as well as five DOD vehicles.
- RFP provided 3-interest free loans via the Rural Fire Revolving Loan Fund.

 - Bradley Co. Rural '96 Spartan Pump \$15,000.00 D-1 Bradley Co.
 - Boston Mtn. '09 Freightliner \$11,616.17 D-6 Crawford Co.
- VFA Grant: The narrative for the FY19 VFA Grant has been submitted to the USFS. An increase this year was received from \$304,614 to \$335,005.
- 2019 Annual Rural Fire Show: Registrations are starting to come in from vendors. The postcards have been ordered to begin advertisement to FDs about the show.
- Attended the Rural Development Conference in Hot Springs as a vendor.
- Met with Senator Kim Hammer along with Joe Fox and several other state agencies about improving services to fire departments statewide. He plans to hold another meeting in June.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas is proud to have 82 active Firewise communities. Recognized communities display Firewise signs at the city limits.

Firewise achieved the following in **May**:

- Hosted informational booth at Arkansas Rural Development Conference
- Delivered Firewise unit at Arkansas Wildland Fire Academy
- Delivered Firewise unit at Arkansas Fire Academy's Wildland Class
- Attended one Community Firewise educational event
- Delivered initial program presentation to one community

Law Enforcement: AAD has the authority to enforce the laws of the State of Arkansas, but primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and focuses vandalism. AAD aggressively seeks prosecution of violators to deter such crimes. AAD Investigators and district law enforcement officers opened four dumping, two fire related and five timber theft cases. They closed four dumping and two timber theft cases.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 410,820 acres of private land actively enrolled in the Forest Stewardship Program. Landowners that implement practices under their FSP management plans become Certified Forest Stewards. There are 1,257 Forest Stewards owning 282,612 acres in the State.

For May, 44 FSP plans were prepared on 5,760 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 40 forest management practice plans on 3,649 acres.

Reforestation: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

The following are final numbers for the FY19 planting season:

- End of the year through May 31, there were
 - 704 online orders and 186 paper orders
 - Total sales of 1,260,050 pine and 5,861,675 hardwood
 - Comparatively, in FY 18, there were
 - 787 online orders and 248 paper orders
 - Total sales of 1,556,400 pine and 5,160,375 hardwood
- Lifted and packed the following for FY19 through May 31
 - 1,378,500 pine
 - 6,021,175 hardwood
 - 26,700 Containerized 3-star loblolly pine
 - 90,600 Containerized Advanced Gen shortleaf pine
 - Total seedlings packed = 7,516,975
- Shipped the following for FY19 through May 31

- 1,108,050 pine
- 5,841,775 hardwood
- 25,925 Containerized 3-star loblolly pine
- 83,600 Containerized Advanced Gen shortleaf pine
- Total seedlings shipped = 7,059,350

During the month of May, the Baucum Nursery staff completed the following:

- Corrected field drainage
- Hosted Carrie Pike from USFS. Tour of nursery and hardwood seed orchards. Discussion of cooperative opportunities between state and USFS
- Maintaining a 15 ft. herbicide buffer around all fields
- Completed installation of all irrigation
- Sprayed riser lines with pre-emergence herbicide in all fields
- Covered exposed seed that were washed out from excessive rain
- Bush-hogged around fields and in all orchards

Tree Improvement: AFC's tree improvement program provides landowners with the highest possible genetic gain in pine and hardwood seed.

During the month of May, the Bluff City Tree Improvement staff completed the following:

- Completed removing pollination bags
- Cataloged pollen for cold storage.
- Picked up AFC cone harvest seed from Oklahoma
- Delivered pine seed to Baucum for storage
- Finished pot grafting pine
- Reforestation Manger and Reforestation Foreman attended Western Gulf Forest Tree Improvement Cooperative meeting in College Station Texas
- Bush-hogged water lines in orchards 1718, 1719, 1720, and 1721
- Fertilized transplanted grafts in orchards 1718, 1719, 1720, and 1721
- Weeded trees in 7 gal pots outside greenhouse
- Inventoried grafted pine and moved out of greenhouse into shade house
- Bush-hogged along tree rows in orchards 1718, 1719, 1720, and 1721 for spraying herbicides
- Picked up lumber to build new racks for rootstock
- Removed vetch vines from young grafts in orchards

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

Urban & Community Forestry

- Participated in coordination of the Project Learning Tree International conference held in Little Rock. AFC provided welcome address, Smokey presence, and behind the scenes coordination.
- Provided Miller County with tree management planning for large county-owned park. AFC will continue to work with county personnel as park is developed.
- Reviewed accomplishments and prepared annual work plan for the AR Urban Forestry Council.
- Prepared application for 2019 Urban & Community Forestry Grant Program to fund community projects that develop/improve public tree management and maintenance. Applications will be accepted June 12-July 20, 2019 and recipients notified by September 15, 2019.

Forest Health: The Forest Health Specialist assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

- A Forest Health Workshop was offered to AFC and University of Arkansas Extension. Over 50 attendees were trained to recognize all current threats to Arkansas Forests.
- **Jumping oak gall** was determined responsible for the unhealthy appearance of **white oaks** in the northwestern and north-central counties of Arkansas. This tiny wasp is so

numerous that hundreds of galls are made on the underside of leaves and, subsequently, leaves brown and die. It is not expected to kill the affected white oaks.

- The Forest Health Specialist identified signs of **emerald ash borer** in Mountain Home. Marion County was confirmed last year by a positive trap, but this is the first reported observation of attacked trees there.

Best Management Practices (BMP): AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

BMP achieved the following in May 2019:

- Attend Registered Forester training conference.
- BMP training for 26 AFC employees.
- Exam on Greenbay Packaging 740 ac. tract in Conway Co.
- Exam on 20 ac. tract in Conway Co .for logger/landowner.
- Exam on 484 ac. tract in Columbia Co. with harvest in process.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

FIA completed 65 plots for the month of May. We are currently 28% complete with the 2019 Survey.
