Arkansas Department of Agriculture/Forestry Division July 2019 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During July a total of fifteen wildfires were suppressed for a total of fifty-one acres burned. Ten-year average for the month of July is 123.9 wildfires 1,581.2 acres burned.

Search and Rescue Assistance: A Forestry Division crew in Carroll County assisted in searching for a three-year-old child. The child was found safe. A crew in Clark County assisted in a search and rescue for kids on the Caddo River. The kids were found safe.

Storm Damage Assistance: A Forestry Division crew assisted with rescues during flooding in the Delight area of Pike County.

Rural Fire Protection: Rural Fire Protection (RFP) assists fire departments (FDs) with organization, training and equipment. RFP provides interest-free loans, secures firefighting and emergency service equipment from the federal government, and administers a federal grant to assist approximately 1,000 fire departments. The RFP shop provides maintenance to property destined for FDs and repairs Forestry Division equipment.

July 2019

- Seven wildland fire training classes were conducted with sixty-three FDs represented (146-firefighters), eight minority departments, and four Forestry Division personnel in attendance.
- RFP received one two-wheel drive Freightliner (valued at \$162,968.00).
- There were six Department of Defense (DOD) vehicles issued to FDs; six Freightliners (valued at \$995,875.00).
- RFP received 141 DOD Recycling Control Point (RCP) items (valued at \$21,583.59) for redistribution to FDs this month, including spill kits, scissors, spine boards, and stretchers.
- The RFP shop completed maintenance on three Forestry Division vehicles and equipment as well as six DOD vehicles to be placed with FDs.
- RFP provided four interest free loans via the Rural Fire Revolving Loan Fund.

- 2019 Rural Fire Show (October 5): Twenty-two vendors have pre-registered. Postcards have been mailed out to FDs about the show, as well as information about deadlines for Firewise renewals. A few door prizes have been secured.
- Nine counties have turned in and cleared Fire Fighter Program (FFP)/Federal Excess Personal Property (FEPP) inventory. All districts have received inventory.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas is proud to have eighty-two active Firewise communities. Recognized communities display Firewise signs at the city limits.

Firewise achieved the following in **July**:

- Attended one County Fire Association meeting to discuss program with ten Fire Chiefs.
- Assisted one community with renewal paperwork.
- Delivered educational materials for a community's projects.
- Met with fire department interested in re-entering program; answering all questions and concerns.
- Delivered Risk Assessment training to one community.

Law Enforcement: Arkansas Department of Agriculture has the authority to enforce the laws of the State of Arkansas, but primarily focuses on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. The Department aggressively seeks prosecution of violators to deter such crimes. Department investigators and district law enforcement officers opened two dumping, eight timber theft, and one property damage cases. They closed four dumping, ten fire, twenty-two timber, one property damage, and one division assist cases.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: The Forestry Division works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and\or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or Forestry Division foresters, private consulting or Arkansas Game and Fish Commission (AGFC) private lands wildlife biologists, and United States Department of Agriculture (USDA) Natural Resource Conservation Service soil and water professionals. Arkansas has 415,171 acres of private land actively enrolled in the Forest Stewardship Program. Landowners that implement practices under their

FSP management plans become Certified Forest Stewards. There are 1,263 Forest Stewards owning 283,369 acres in the State.

For July, ten FSP plans were prepared on 2,607 acres. In addition, Forestry Division personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and Southern Pine Beetle Prevention and Restoration Program. Forestry Division foresters prepared eighty-six forest management practice plans on 6,680 acres. Forestry Division personnel conducted ten prescribed burns on 299 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers, and homeowners on urban tree care, inventory, and management.

Urban & Community Forestry- July 2019

- Examined flood damage to trees in a public park in Pine Bluff and offered advice on damage recovery to Parks Dept. personnel.
- Inspected a completed sub-award project in Jefferson County.
- Wrote an article for the Arkansas Municipal League City & Town magazine on growing fruit trees in communities.
- Began reviewing the 2019 Urban & Community Forestry grant applications. Grant recipients will be notified in September.
- Planned an International Society of Arboriculture Tree Risk Assessment training to be held in Little Rock in September. Forestry Division and municipal staff from several communities will be trained to provide hazard tree assessments.

Forest Health: The Forest Health Specialist assists Forestry Division personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. The Forestry Division offers technical assistance to landowners who encounter forest health issues.

- The Forest Health Specialist attended the Southern Forest Insect Work Conference to discuss regional forest health issues and share information about the white oak infested with jumping oak gall in the Ozarks. This gall-forming insect does not directly kill trees, but it has been more abundant recently, which has caused some concern.
- Two aerial surveys were conducted to assess storm damage and to detect pine bark beetles in the lower Ouachita areas.
- The Southern Pine Beetle Prevention Program continues to offer monetary incentives to landowners who thin overly dense pine forests. Landowners can apply for the program through local Forestry Division offices.

Reforestation: The Forestry Division's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method we employ to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. The Forestry Division's Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

Reforestation Manager, Dave Bowling, Nursery Manager, James Shelton, and Reforestation Foreman, Randy O'Neal, attended the Southern Forest Nursery Management Cooperative (SFNMC) annual contact meeting. This year the meeting was held in Bossier City, LA. There were 40 forestry professionals in attendance for presentations and research reports on nursery management. The field trip this year was to Weyerhaeuser Nursery in Magnolia AR. The tour included review of soil fumigant trials by both SFNMC staff and Weyerhaeuser Research staff.

Reforestation Manager, Dave Bowling, and Nursery Manager, James Shelton, met with Drew Green and Steve Burgess from Arkansas Game and Fish Commission at Baucum Nursery to assess the seedlings we are growing for them.

Nursery Manager, James Shelton, took the entire nursery staff on a field trip to Arbor Gen Nursery and the Forestry Division Tree Improvement Complex at Bluff City. Reforestation Manager, Dave Bowling, gave a short presentation to the nursery staff on the history and purpose of tree improvement and led a brief tour of the Tree Improvement Complex.

Baucum Nursery: The Forestry Division's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 1 with pre-order payment period. There were seventy-four customers who placed pre-orders and fifty-two of them completed processing their pre-order by paying for their seedlings during the pre-order payment period, July 1 through July 15. Total collected from online pre-orders was \$58,194,83

Regular season seedling sales began on July 16.

Year to date through July 31, there were ninety online orders and sixty-eight paper orders. Total sales of 372,050 pine and 6,737,311 hardwood.

Comparatively, during the same period in FY 19, there were 149 online orders and forty-four paper orders. Total sales of 382,200 pine and 6,072,056 hardwood

During the month of July, Baucum Nursery staff completed the following:

- Pre-inventory of all species.
- Cleaned out the cooler.
- Removed all debris from Improved Cherrybark orchard after cutting.
- Began spreading mulch in field seven.
- Sprayed herbicide on fence row next to highway.

Sprayed herbicide around all stored equipment and the tractor shed.

Tree Improvement: The Forestry Division's tree improvement program provides landowners with the highest possible genetic gain in pine and hardwood seed.

During the month of July, the Bluff City Tree Improvement staff completed the following:

- Built more racks for hardwood rootstock.
- Potted 600 seedlings in two gallon pots for hardwood rootstock.
- Fertilized and sprayed herbicide around pine and hardwood rootstock.
- Released 2019 top grafts by pruning limbs below the graft to allow top graft to grow.
- Fertilized transplanted grafts in orchards 1718, 1719, 1720 and 1721.
- Pruned lower limbs in orchards 1717 and 1720.
- Replaced tags in orchard 1708-B for pollen collection in spring.
- Began installing fence for protection from hogs at Dr. Parkes test site.

Best Management Practices (BMP): The Forestry Division provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

BMP achieved the following in July 2019:

- Assisted landowner with information for bottomland logging.
- Assisted PotlatchDeltic with 2018 survey data interpretation.
- Assisted D-2 with BMP newsletter.
- Attended AFA Forest Practice meeting and presented report.

Forest Inventory and Analysis: The Forestry Division in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

FIA staff completed 132 plots for the month of July. We are now 51% complete with the 2019 survey.
