Re: Arkansas Department of Agriculture, Forestry Division's monthly activity report for January 2020

Dear Senator Bledsoe and Representative Wardlaw:

Per Section 33 of Act 544 of the 2019 General Session, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for January 2020.

In January, the Forestry Division met to set priorities for 2020. Our leadership team agreed that the priorities for 2020 are as follows:

Recruitment and Retention
Quality Training
IT advances, both hardware and software

In January, the division recognized the retirement of six veteran employees. Those employees represent a total of 185 years of forestry experience walking out the door. Therefore, our priority is recruitment and retention of new staff. Our next priority is to provide quality training to employees, so they have all needed skills to perform their jobs. Lastly, we will open the door for employees to obtain state-of-the-art tools and technology that allows them to perform job duties safely and quickly.

## Arkansas Department of Agriculture Forestry Division January 2020 Activity and Fiscal Report

### **Emergency Services**

**Wildfires:** During January a total of 32 wildfires were suppressed for a total of 920 acres burned. Ten-year average for the month of January is 127 wildfires with 1,954 acres burned.

**Rural Fire Protection:** Rural Fire Protection (RFP) assists fire departments (FDs) with organization, training and equipment. RFP provides interest-free loans, secures firefighting and emergency service equipment from the federal government and administers a federal grant to assist approximately 925 fire departments. The RFP shop provides maintenance to property destined for FDs and repairs Department equipment as well.

## January 2020

- Six Wildland Fire Suppression training classes were conducted with fifty-seven FDs represented (156 firefighters), including seven Forestry personnel in attendance.
- RFP received the following through the Fire Fighter Program/Federal Excess Property Program (FFP/FEPP) programs: four hydraulic cutters (extrication/forcible entry tools – valued at \$22,698.21).
- The following equipment was issued this month: one drill extinguisher (valued at \$32,500), four generators (valued at \$182,262.50) and four tankers (valued at \$556,123.00).
- Received 42 items in Department of Defense (DOD) Recycling Control Point (RCP) (valued at \$2,171.60) for redistribution to FDs this month to include reflector sets and a ventilation fan.
- The RFP shop completed maintenance on two Forestry vehicles (labor savings of \$255.00).
- RFP provided one interest-free loan via the Rural Fire Revolving Loan Fund to Calhoun VFD in the amount of \$15,738.14 to purchase a 2500-gallon poly-tank installed, truck & tank painted red and truck parts.
- Completed several reports for Legislative Research, Transformation Team and internal report on FD laws, etc.
- Completed audit of FEPP and FFP files in preparation for United States Forest Service (USFS) review early 2020.

- Continued our training for the Health & Safety Plan: Pipeline Awareness, Chemical Storage & Awareness, and Fire Extinguisher Training.
- Seventy-four counties have turned in and cleared FFP/FEPP inventory.
- Met with Marketing Division team (Amy & Anna) discussing RFP, the upcoming Fire Show and other marketing events. They are working to combine new Ag logo with old RFP logo. Have also asked for Marketing's assistance in designing a flyer for this year's Fire Show.

**Firewise:** Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas is one of the top states with 103 active Firewise communities. Recognized communities display Firewise signs at the city limits.

Firewise achieved the following in January:

- · Conducted one risk assessment training session.
- · Delivered two initial program presentations at two fire chiefs' meetings.
- · Personnel attended training on Pipeline Safety, Hazardous Materials, and Fire Extinguishers.
- · Coordinator attended Wildland Instructor Adjunct Training.

Law Enforcement: The department has the authority to enforce the laws of the State of Arkansas, but primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and focuses vandalism. The department aggressively seeks prosecution of violators to deter such crimes. Department investigators and district law enforcement officers opened two fire related and six timber theft cases. They closed three timber theft and two dumping cases.

#### **FOREST MANAGEMENT**

Forest Stewardship/Rural Forestry Assistance Programs: The Forestry Division works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry, and\or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or Division foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 379,615 acres of private land actively enrolled in the Forest Stewardship Program. Landowners that implement practices under their FSP management plans become Certified Forest Stewards. There are 1,268 Certified Forest Stewards owning 285,666 acres in the State.

During the month of January, six Forest Stewardship management plans were prepared for 493 acres. In addition, Forestry Division personnel provide technical assistance through the rural forestry program to landowners that are enrolled in United States Department of Agriculture (USDA) tree planting and forest management programs such as the Conservation Reserve

Program, Environmental Quality Incentives Program, Wetland Reserve Program, and the Southern Pine Beetle Prevention and Restoration Program. Forestry Division personnel prepared 75 forest management practice plans on 3,857 acres and conducted nine prescribed burns on 274 acres.

**Urban & Community Forestry Assistance:** Urban & Community Forestry Program staff provide assistance and training to communities, educational institutions, non-profit organizations, developers, and homeowners on urban tree care, inventory and management.

- Five trees were planted at Ouachita Elementary School to complete the 2019 Shade
   Trees on Playgrounds (STOP) tree plantings.
- Harold Fisher, Urban & Community Forestry Partnership Coordinator, approved ten Tree
  City USA applications for 2019 recertification, assisted five communities with working
  toward completion of their 2019 recertifications, and began discussions with one
  additional city about becoming a new Tree City USA for 2020.
- Urban & Community Forestry Coordinator Krissy Thomason began serving on a nationwide committee tasked with providing information to the NASF on updating Tree City USA Growth Award requirements.
- Harold Fisher gave a tree care and maintenance talk to the city of Greenbrier.
- Krissy Thomason participated in a preliminary meeting with representatives from Audubon Arkansas, Little Rock Parks and Recreation, and Arkansas Forestry Association to draft public messaging promoting forestry activities in the Fourche Bottoms.

Forest Health: The Forest Health Specialist assists Forestry Division personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AR Department of Agriculture – Forestry Division offers technical assistance to landowners who encounter forest health issues.

- Ips pine engraver beetles have contributed to tree mortality in southeastern Arkansas, particularly around Monticello. An aerial survey revealed that the damage was limited only to susceptible stands, most of which were affected by windthrow and saturated soils. Damage in some stands may warrant an early harvesting decision.
- The Forest Health Specialist attended a meeting with the Arkansas Forestry Association Forest Protection Committee to discuss current forest health trends.

**Reforestation:** The Forestry Division's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method The Forestry Division employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. The Forestry Division's Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

**Baucum Nursery:** The Forestry Division's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Regular season seedling sales began on July 16.

Year to date through January 31, there were 508 orders. Total sales of 897,575 pine and 6,643,800 hardwood. Comparatively, during the same period in FY 19, there were 718 orders. Total sales of 1,067,275 pine and 5,861,675 hardwood.

During the month of January, Baucum Nursery staff completed the following:

**Tree Improvement:** The Forestry Division's tree improvement program provides landowners with the highest possible genetic gain in pine and hardwood seed.

During the month of January, the Bluff City Tree Improvement staff completed the following:

- Bush-hogged new hardwood orchard site north of orchard 1713.
- Delivered seedlings to Baucum from ArborGen.
- Pruned limbs in orchard 1715.
- Cut bigger rootstock out of orchard 1718 and 1719.
- Began removing trees missed by loggers in orchards 1715 and 1716.
- Began applying gopher bait in all orchards.
- Inventoried orchards 1718 and 1719 for grafting.

**Best Management Practices (BMP):** Forestry Division provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

BMP achieved the following in January:

- Checked four complaints within White, Hot Spring, Cleveland, and Pike Counties.
- Checked Lincoln County complaint.
- Attended Southern Group of State Foresters (S.G.S.F) Water Resource meeting in Auburn, AL.
- Assisted timber contractor with possible use of bridge timbers.
- Worked on 319(h) grant application.
- Closed out Pike County complaint.

Forest Inventory and Analysis (FIA): Forestry Division in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas's natural resource trends through time.

FIA completed 95 plots for the month of January. We are 99.5% complete with the 2019 inventory and plan to complete the remaining 2019 plots within a week.
