Dear Secretary Walther:

On behalf of the Department of Human Services, I respectfully request a release of Covid-19 Rainy-Day Funds for the Crisis Stabilization Unit (CSU) programs. These programs provide a needed alternative to jail for individual program who are suffering a mental health crisis and are behaving in a way that appears to be threating others. The pilot programs are in Craighead, Pulaski Sebastian and Washington counties. These local resources allow police officers an alternative option to holding an individual overnight in jail. At these CSU's staff are trained to stabilize and then assess what is best for the person. The CSUs may provide services in excess of 24 hours, but not more than 96 hours during an episode.

Recognizing the hardship significantly reducing of funds would have on the operations plans of these pilot programs the agency is requesting appropriation and rainy-day funds in the amount of \$2,036,000. Requested funding will allow the programs to be reimbursed for actual and projected expenditures through June 30, 2020.

Funding for these pilot programs have relied on a combination rainy-day, agency carry-forward and "B category" state general revenue. Recent reductions and lower forecasts for FY21 state general revenue for next fiscal year threatens the continuing operation of these pilots.

If this request is approved estimated reimbursement for this state fiscal year will be allocated in the following manner:

-	Craighead County	\$532,000
-	Pulaski County	\$532,000
-	Washington Cunty	\$532,000
-	Sebastian County	\$440,000
Total		\$2,036,000
