HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,604.2 million have increased \$170 million, or 3.1%, above the \$5,434.2 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$657.1 million decreased \$3.8 million, or 0.6%, from the \$660.9 million available for distribution in April 2017. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,242,988.57 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$22,429,885.70.

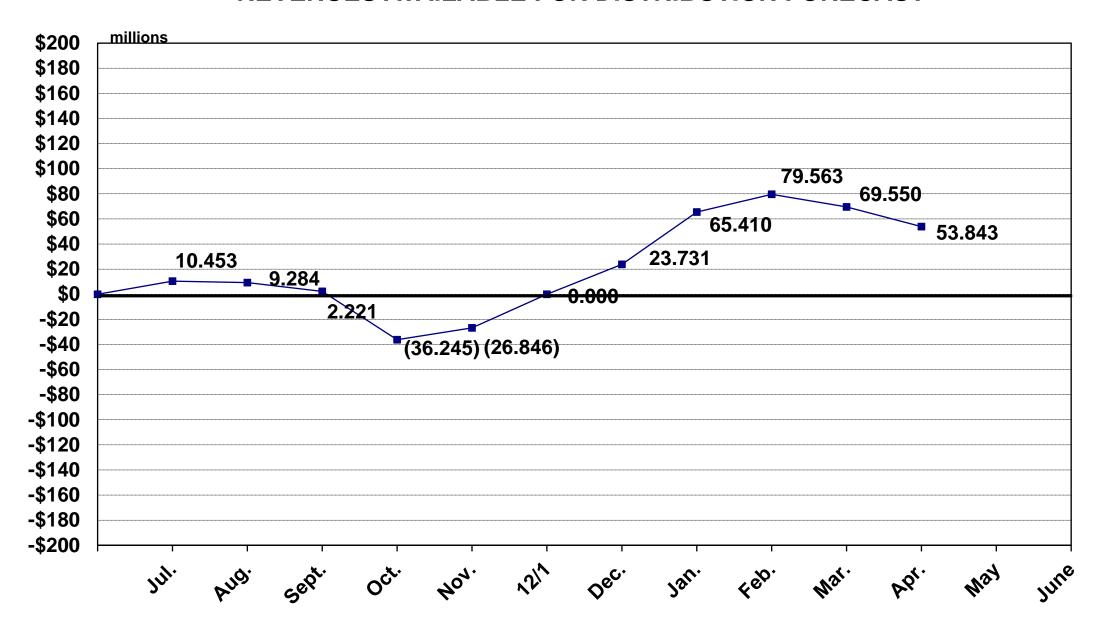
