HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$6,078.6 million have increased \$174.9 million, or 3.0%, above the \$5,903.7 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$347.4 million increased \$8.1 million, or 2.4%, from the \$339.3 million available for distribution in May 2017. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,242,988.57 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$24,672,874.27.

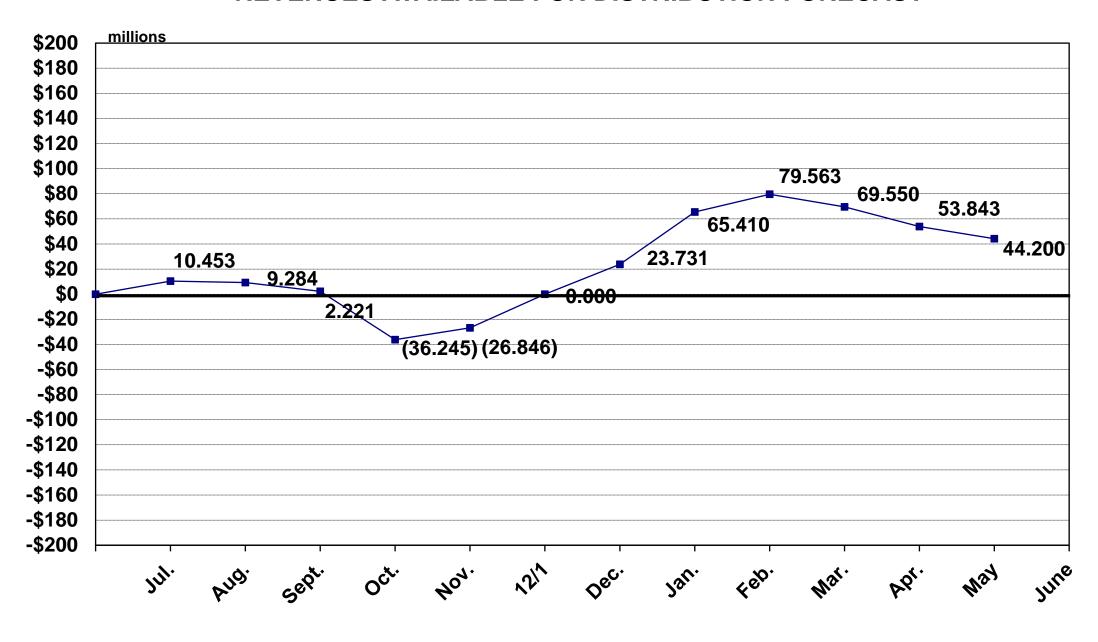
