Collections of Gross General Revenues year-to-date of approximately \$6,738.3 million have increased \$167.9 million, or 2.6%, above the \$6,570.4 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$557.9 million decreased \$13.8 million, or 2.4%, from the \$571.7 million available for distribution in May 2017. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,242,988.57 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$26,915,862.84.


