HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$1,024.2 million have increased \$29.5 million, or 3.0%, above the \$994.7 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$434.1 million increased \$28.2 million, or 6.9%, from the \$405.9 million available for distribution in August 2017. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,207,773.40 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$4,415,546.80.

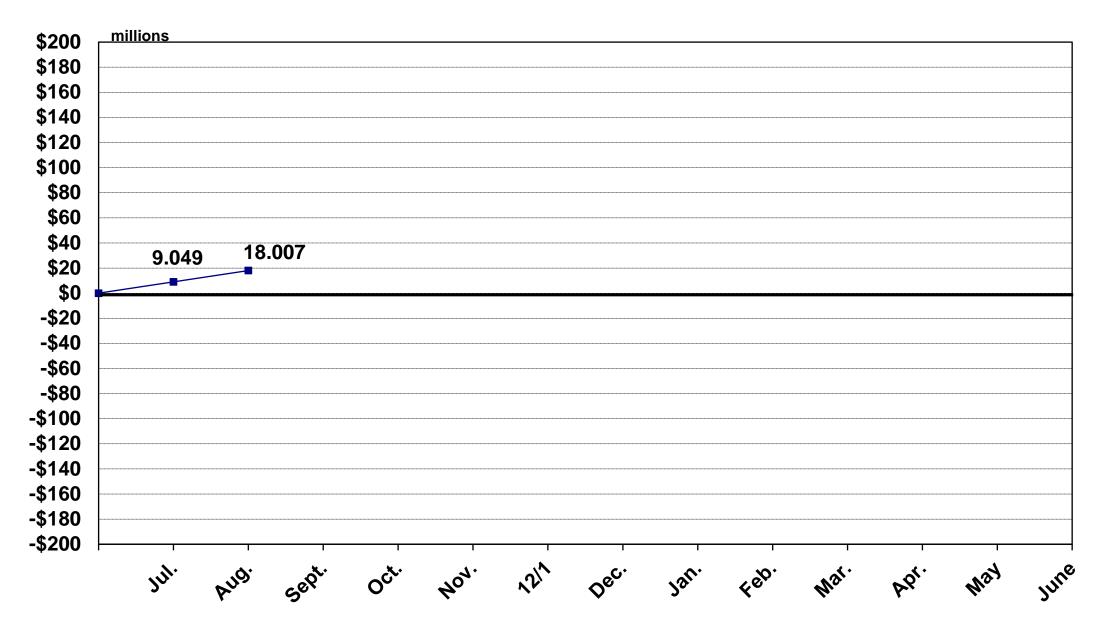
