Collections of Gross General Revenues year-to-date of approximately \$1,659.9 million have increased \$77.5 million, or 4.9%, above the \$1,582.4 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$569.6 million increased \$50.8 million, or 9.8%, from the \$518.8 million available for distribution in September 2017. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,207,773.40 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$6,623,320.20.

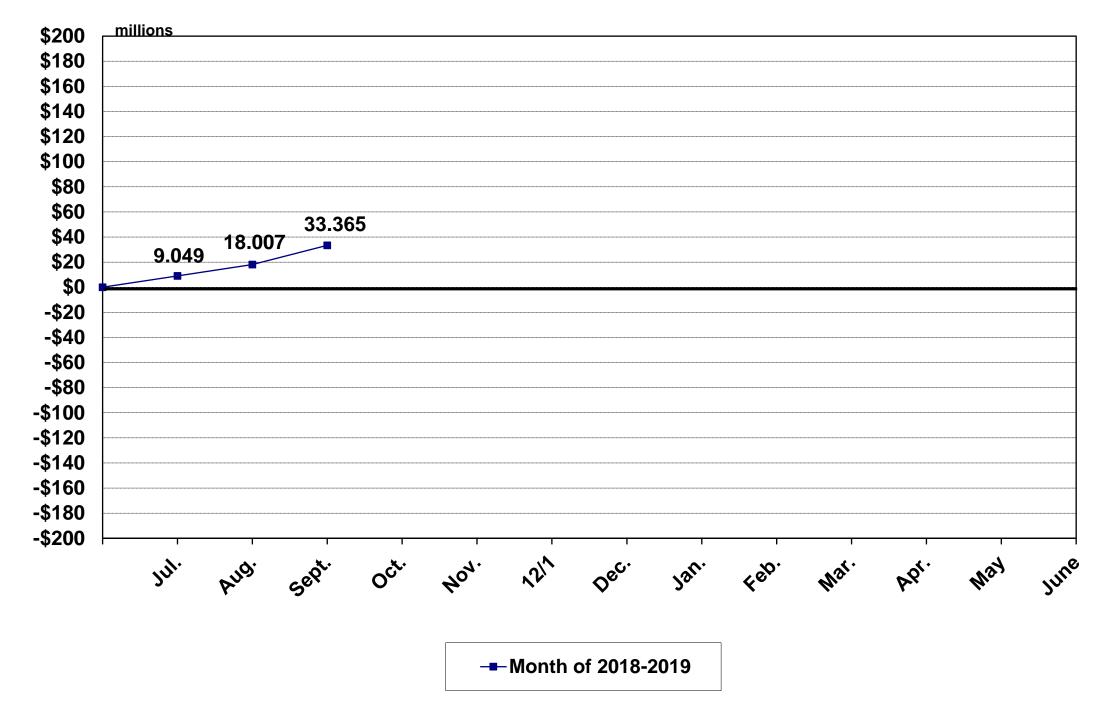
