Collections of Gross General Revenues year-to-date of approximately \$2,084.3 million have increased \$29.5 million, or 1.4%, above the \$2,054.8 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of 414.5 million decreased \$24.6 million, or 5.6%, from the \$439.1 million available for distribution in October 2016. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,242,988.57 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$8,971,954.28.

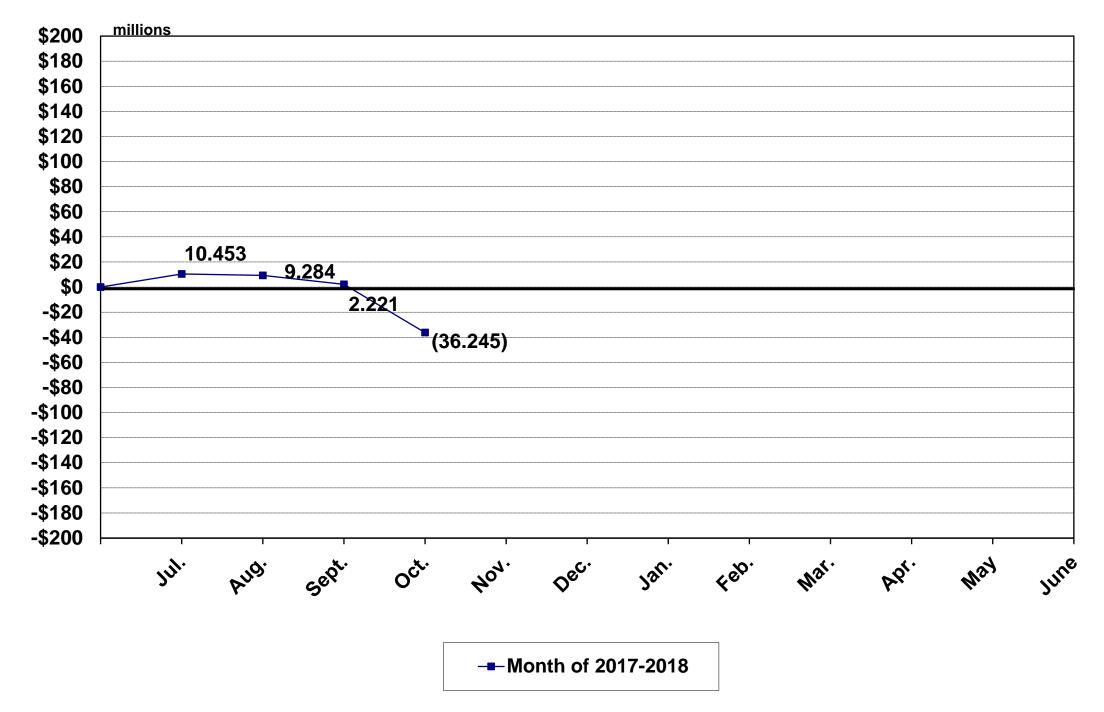
