1. Family Violence Prevention and Services Act

Amount	\$ 1,149,461.00
Purpose	To assist States in supporting the establishment, maintenance, and expansion of programs and projects to prevent incidents of family violence and to provide immediate shelter and related assistance for victims of family violence and their dependents that meet the needs of all victims, including those in underserved communities
Source	U. S. Department of Health and Human Services, Administration for Children and Families
Conditions	DFA-IGS acts as the Single Point of Contact for the funds. As the grantee, the funds are to be awarded to nonprofit organizations across the state providing programs according to federal funding criteria

2. Sexual Assault Services Program (SASP)

Amount	\$ 169,195.00
Purpose	To assist States in supporting rape crisis centers and other nonprofit, nongovernmental organizations that provide core services, direct intervention, and related assistance to victims of sexual assault.
Source	U. S. Department of Justice, Office on Violence Against Women
Conditions	DFA-IGS acts as the Single Point of Contact for the funds. As the grantee, the funds are to be awarded to rape crisis centers and other nonprofit, nongovernmental organizations across the state providing programs according to federal funding criteria

3. STOP Violence Against Women Act

Amount	\$ 1,554.789.00
Purpose	To assist states to support projects statewide that develop and strengthen effective law enforcement and prosecution strategies and victim services in cases involving violent crimes against women (STOP program funds)
Source	U. S. Department of Justice, Office on Violence Against Women
Conditions	DFA-IGS acts as the Single Point of Contact for the funds. As the grantee, the funds are to be awarded to nonprofit organizations and judicial, law enforcement, prosecutorial and governmental entities across the state providing programs according to federal funding criteria

4. Victims of Crime Act (VOCA)

Amount	\$ 4,237,023.00
Purpose	To assist States in supporting programs that provide direct services to crime victims who have suffered physical, sexual, financial or emotional harm as a result of the commission of a crime by another person or persons.
Source	U. S. Department of Justice, Office for Victims of Crime
Conditions	DFA-IGS acts as the Single Point of Contact for the funds. As the grantee, the funds are to be awarded to nonprofit organizations and judicial, law enforcement, prosecutorial and governmental entities across the state providing programs according to federal funding criteria

5. Enforcement of Underage Drinking Laws (EUDL)

Amount	\$ 300,000
Purpose	To assist States in supporting programs that enforce the states underage drinking laws
Source	U. S. Department of Justice, Office of Justice Programs
Conditions	DFA-IGS acts as the Single Point of Contact for the funds. As the grantee, the funds are to be awarded to multiple local law enforcement agencies across the state providing programs according to federal funding criteria (youth task forces to educate and eliminate underage drinking, underage drinking awareness advertising campaigns, and collaboration with other agencies to sponsor innovative programs to eliminate underage drinking).
