

Dear Senators Salmon and Key and Representatives Baker and McLean:

The purpose of this letter is to request a suspension of the rules in connection with the required review process for the attached professional services contract for an amendment for the Arkansas Minority Health Commission (AMHC) with the University of Arkansas for Medical Sciences.

The Office of State Procurement of the Department of Finance and Administration erred in not submitting this contract amendment for the November review by the PEER Subcommittee of the Arkansas Legislative Council. The agency bears no fault for the failure to timely submit this contract.

The Arkansas Minority Health Commission currently has a contract with UAMS College of Public Health, which works with medical consultants and others to obtain and analyze data to monitor health disparity indicators. This request is an amendment in the amount of \$24,500, bringing the total amount of the contract to \$87,500, all in state funds. Holding this contract until the next regularly scheduled meeting of the Review Subcommittee would interrupt the research and report compilation that began in November of 2011.



RE: Hope Migrant Farm Labor Center (HMFLC) Building Project

Dear Richard:

The Department of Workforce Services (DWS) has managed the Hope Migrant Farm Labor Center (HMFLC) since 1954 using federal funds to serve migrant farm laborers. In 1998, DWS received a \$2.2M grant from the US Department of Labor (USDOL) to purchase the 16 acres for the HMFLC and to build the existing facility. Thus, DWS owns the complex. In 2007, we received a \$400,000 grant from US Department of Urban Development to build a new dormitory building for additional capacity. We have operated the HMFLC with an annual grant from the USDOL which in recent years has been \$333,300 a year. Then two years ago we received notice that the funds would be discontinued over a three year period with declining amounts provided each year. This will allow DWS to operate the HMFLC through October 2013.

Also, the Hope Workforce Services Center, Hope Arkansas, is in need of replacement as it is in a state of disrepair. DWS owns this property in downtown Hope. It is more economical to remodel the HMFLC to become the new Workforce Center than it is to repair the downtown facility. The estimated total cost of the remodel project is \$2.5 million.

To preserve its cash reserves, DWS requested from the Arkansas Department Finance Authority (ADFA) a loan to be repaid over time. DWS anticipated using its Special Fund, funded by Penalties and Interest paid by Arkansas employers, to repay the loan. ADFA agreed to provide the funds but has since learned that there is a legal obstacle that prevents the transaction from occurring. Act 115 of 2011 was passed to remove any restrictions to allow DWS to borrow funds to support this project.

But an unforeseen issue has arisen suggesting that DWS would need specific legislative authority to borrow funds in addition to its open-ended authority to administer the Unemployment Insurance law.

DWS' current appropriation for construction is limited to \$377,500 a year from its Special Fund therefore the Department of Workforce request the Department of Finance and Administration to adjust/transfer \$1,000,000 of our appropriation to utilize our Special Fund to support this project in accordance with Act 282, Section 22 Special Language transfer of appropriation and as outlined below.
