Subject: State Procurement Semiannual Minority Report – Fiscal Year 2012

The Office of State Procurement (OSP) works jointly with the Small and Minority Business Division (SMB) of the Arkansas Economic Development Commission to analyze the State's usage of minority businesses in contracting. Act 1222 of 2009, more commonly known as the Minority Business Economic Development Act (MBDA), clarified language in Ark. Code Ann. § 15-4-301 and developed new reporting criteria for State agencies, colleges and universities of their usage of minority businesses, which is reported through the Minority Business Advisory Council to the Governor.

Arkansas Code sections 1-2-503 and 15-4-303(1)(A) define a minority as a lawful permanent resident of this state who is:

- (A) African American
- (B) Hispanic American
- (C) American Indian
- (D) Asian American
- (E) Pacific Islander American, or
- (F) Service Disabled Veteran

Note: Arkansas's definition does not include gender; therefore, women-owned businesses are normally not reported. However, at a Committee Member's request, that information is included below.

Section 25-36-104 of the Arkansas Code requires a semiannual report be sent to the Governor and to the co-chairs of the Legislative Council, the Legislative Joint Auditing Committee and the Minority Business Advisory Council on the following:

(A) The dollar amount for State contracts greater than \$25,000 awarded to minority-owned businesses. OSP awarded a total of 562 contracts during this time period totaling \$1,033,874,209.

The Office of State Procurement processes solicitations greater than \$25,000 for state agencies. The issuance of the solicitation and award of the contract adhere to the laws and rules of the Arkansas Procurement Code. These awards are made to the responsive and responsible bidder who is determined to offer the lowest pricing. OSP also creates statewide contracts for all state agencies and Arkansas governmental entities to use. When a contract of this type is created, the buyer estimates the total expected annual usage. In FY12, 58.7% of the contracts awarded by OSP were statewide contracts.

It is with great pleasure that the Small and Minority Business Division (SMB) of the Arkansas Economic Development Commission (AEDC) and the Arkansas Minority Business Advisory Council (AMBAC) present to you the Annual Arkansas Minority Business Spend Report. This report provides information on Fiscal Year 2012 state purchases made with minority business enterprises as reported in the MinorityView Portal.

According to Act 1222, "All state agencies, boards, commissions, colleges and universities shall attempt to ensure that ten percent (10%) of the total amount expended in state-funded and state-directed public construction programs and in the purchase of goods and services for the state each fiscal year is paid to minority businesses."

AEDC's Small and Minority Business Division is responsible for tracking participating agencies, boards, commissions, colleges and universities in their procurement expenditures regarding goods, services, construction and design with minority businesses. SMB rolled out the MinorityView Portal in an effort to help track and monitor agency spend performance with MBEs.

AEDC's Small and Minority Business Division and the Minority Business Advisory Council are committed to ensuring that everyone has an equal opportunity to participate in the Arkansas economy. This commitment is now being implemented throughout the various departments of state government from top to bottom and enforced in part through a continued commitment to the goals and objectives of Act 1222. Through the leadership of Governor Mike Beebe, opening access to minority-owned businesses interested in doing business with the state will continue to be a major focus across state agencies.
