REPORT OF THE ADMINISTRATIVE RULES AND REGULATIONS SUBCOMMITTEE OF THE ARKANSAS LEGISLATIVE COUNCIL

December 21, 2012

Co-Chairs:

The Subcommittee on Administrative Rules and Regulations met at 9:30 a.m. on Wednesday, December 12, 2012, in Room 171 of the State Capitol. The Education Committees met on November 26, 2012 and December 10, 2012. Representative Roebuck presented the committees' report (attached), and the report was adopted by the Administrative Rules and Regulations Subcommittee.

The Subcommittee then passed a motion by Representative Roebuck to allow the Department of Education to pull down its proposed Educator Licensure Rule because the Department of Education is pursuing and re-promulgating an amended Educator Licensure Rule, and the Board of Education has approved such rule on an emergency basis. The revised rules will be presented to the Administrative Rules and Regulations Subcommittee at a later date.

The Repeal of the Department of Education's Rule Governing Waivers for Substitute Teachers was subsequently reviewed by the Administrative Rules and Regulations Subcommittee.

Chairman Malone and Chairman Word:

At its meeting on November 5, 2012, the Administrative Rules and Regulations Subcommittee of the Arkansas Legislative Council referred the following proposed rules from the Arkansas Department of Education (ADE) to the Senate Interim Committee on Education and House Interim Committee on Education:

- Educator Licensure and Proposed Repeals
- Repeal of Arkansas Department of Education Rules Governing Waivers for Substitute Teachers

At a joint meeting on November 26, 2012, the Senate Interim Committee on Education and the House Interim Committee on Education heard a presentation by the ADE regarding the ADE's Proposed Rules Concerning Educator Licensure and Proposed Repeals. Following examination of the proposed rule, discussion by the Committees, and testimony from representatives of the ADE, this is to advise that the Committees adopted a motion to review the rule, with the specific exception of Section 4.0, which dealt with Ancillary Licensure Requirements (School Psychology, Speech Language Pathology, and School Counseling). Although the ADE's proposed Repeal of Arkansas Department of Education Rules Governing Waivers for Substitute Teachers was scheduled to be discussed at the November 26th meeting, circumstances necessitated deferral of consideration of this rule until the Committees' December 10, 2012, meeting.
