3	URGING CONGRESS AND THE PRESIDENT OF THE UNITED STATES TO STAND
4	BESIDE ISRAEL IN THE FACE OF INCREASED ATTACKS UPON ISRAEL AS A
5	SOVEREIGN NATION, TO HONOR OUR NATION'S LONG-STANDING
6	RELATIONSHIP WITH ISRAEL AS AN ALLY, AND TO SUPPORT THE ARKANSAS
7	JEWISH COMMUNITY AND THE NATION OF ISRAEL.
8	
9	BE IT RESOLVED BY THE ARKANSAS LEGISLATIVE COUNCIL OF THE 88TH GENERAL
10	ASSEMBLY OF THE STATE OF ARKANSAS:
11	
12	WHEREAS, Israel is one of our country's strongest allies and shares
13	common democratic values and national interests with the United States; and
14	
15	WHEREAS, Israel is a small country in a strategically vital and
16	increasingly inhospitable region of the world; and
17	
18	WHEREAS, Israel has been repeatedly targeted by unprovoked rocket
19	attacks and acts of terrorism; and
20	
21	WHEREAS, more than one thousand one hundred fifty (1,150) rockets
22	have been fired upon the nation of Israel since the beginning of 2012; and
23	
24	WHEREAS, more than four thousand (4,000) rockets and mortar shells
25	have been fired at Israel from the Gaza Strip by Hamas and other terrorist
26	organizations since Israeli forces were withdrawn in 2005; and
27	
28	WHEREAS, the rocket fire has been targeted primarily and intentionally
29	at civilian communities in Israel, damaging homes, buildings, roads, power
30	lines, and other infrastructure; and
31	
32	WHEREAS, the attacks have forced Israel to suffer dozens of
33	casualties, hundreds of shock victims, thousands of traumatized children, and
34	the severe disruption of daily life; and

1	WHEREAS, the unprovoked rocket attacks and acts of terrorism represent
2	the greatest obstacles to Israel's ongoing attempts to achieve a lasting
3	peace with the Palestinians; and
4	
5	WHEREAS, the United States and Israel maintain a special relationship
6	based on shared cultural and political values and common interests; and
7	
8	WHEREAS, since September 11, 2001, the United States has benefited in
9	the war against terrorism from Israel's experience, expertise, innovations,
10	and cooperation, saving American lives and bolstering America's defense; and
11	
12	WHEREAS, the United States and Israel share a core strategic belief
13	that democratic reform in the Middle East can bring peace and change to the
14	political environment that breeds terrorists and funds terrorism; and
15	
16	WHEREAS, Israel is an extremely capable and willing ally of the United
17	States, as evidenced by Israel's support for the United States' positions in
18	international forums such as the United Nations,
19	
20	NOW THEREFORE,
21	BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE EIGHTY-EIGHTH GENERAL
22	ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	THAT the Legislative Council:
25	(1) Condemns, in the strongest possible terms, rocket attacks
26	and any form of terrorist act upon the nation of Israel and its civilian
27	population;
28	(2) Supports the sovereign right of Israel to defend its
29	territory and stop the rocket attacks on its citizens;
30	(3) Regards rocket attacks and the fostering of terrorism in the
31	Palestinian territories as direct hindrances to the peace process in the
32	region;
33	(4) Reaffirms the strong and unyielding friendship between the
34	governments and the people of Israel and the United States; and
