HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$468.5 million have increased \$5.5 million, or 1.2%, above the \$463 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$410.2 million increased \$6.3 million, or 1.6%, from the \$403.9 million available for distribution in July 2012. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,276,239.83 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$2,276,239.83.

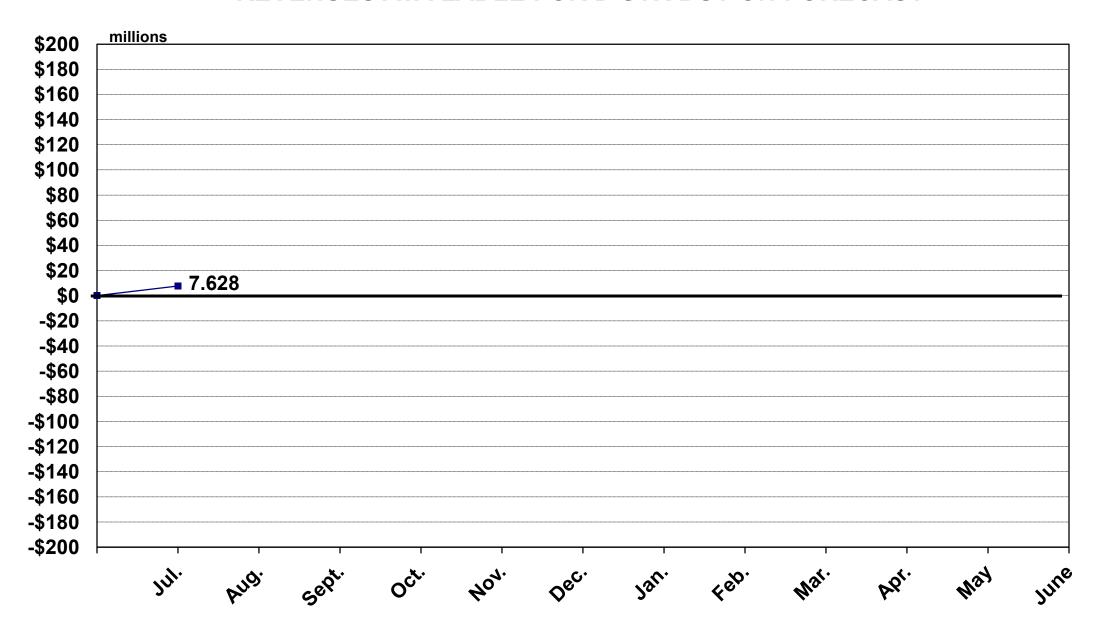
