Collections of Gross General Revenues year-to-date of approximately \$5,423 million have increased \$214.2 million, or 4.1%, above the \$5,208.8 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$624 million increased \$53.8 million, or 9.4%, from the \$570.2 million available for distribution in April 2014. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,251,485.28 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$22,514,852.80.

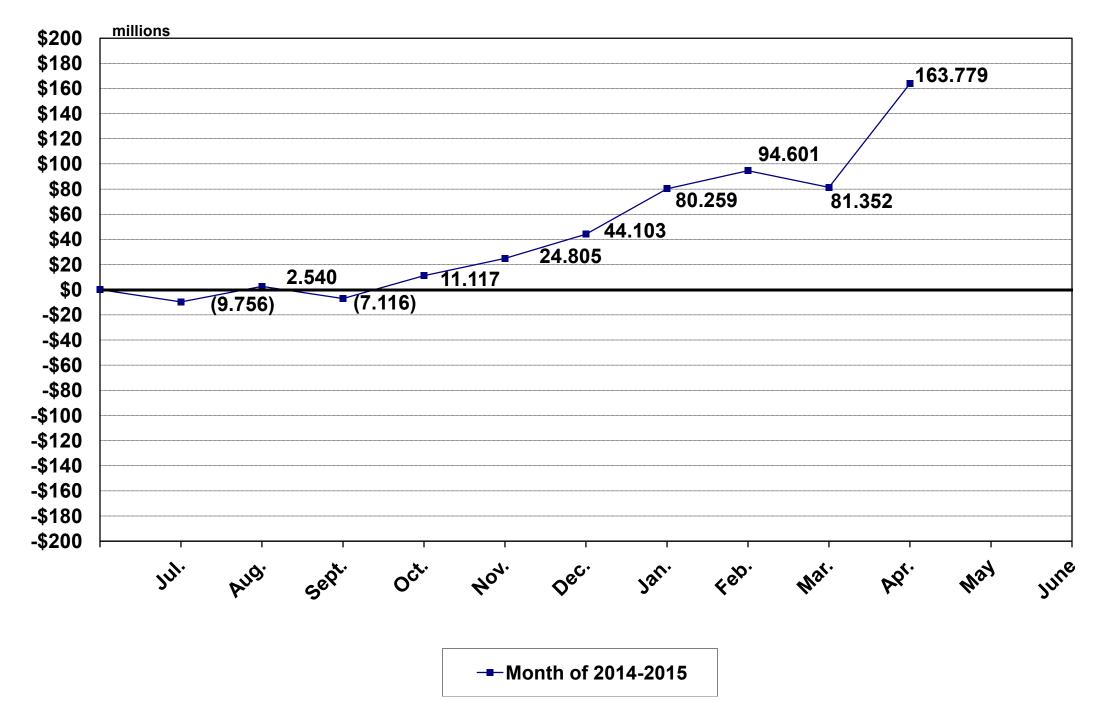
