HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Prepared by: THE BUREAU OF LEGISLATIVE RESEARCH

Collections of Gross General Revenues year-to-date of approximately \$948.4 million have decreased \$17.5 million, or 1.9%, above the \$930.9 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$421.4 million increased \$23.1 million, or 5.8%, from the \$398.3 million available for distribution in August 2014. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,692,523.84 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$5,385,047.68.

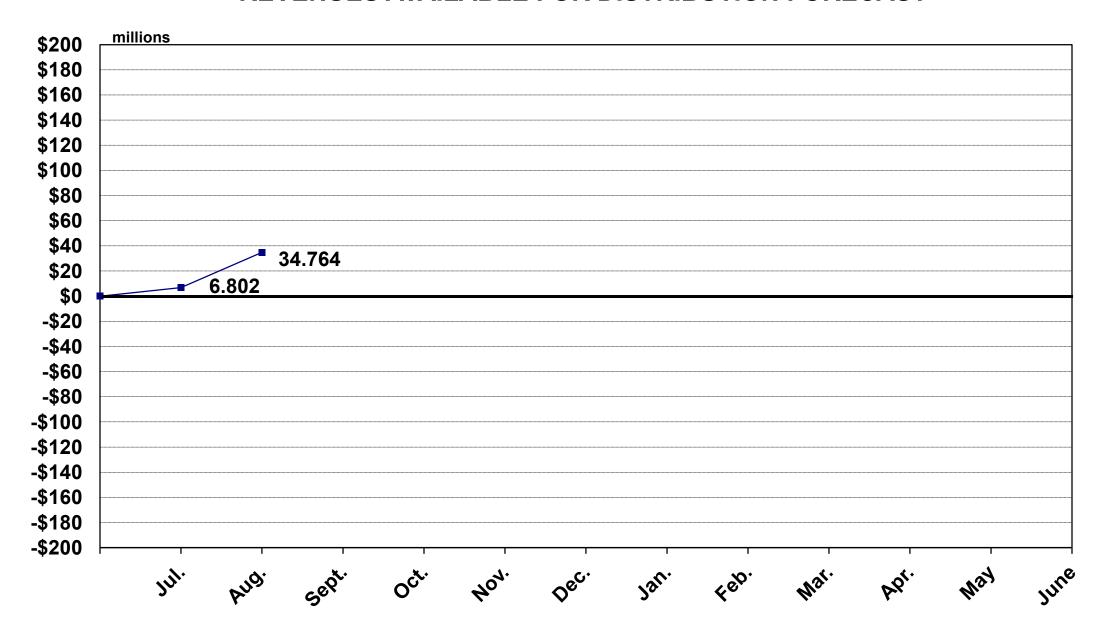
