So, you can see why we are very proud of our FireWise Program that leads the nation with 151 FireWise communities.

ARKANSAS FORESTRY COMMISSION August 2015 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During August, a total of 126 wildfires were suppressed with a total of 1,128 acres burned. Ten year average for the month of August is 189 wildfires with 2,474 acres burned.

Search and Rescue Assistance: An AFC crew consisting of two rangers from Washington County assisted in a search and rescue operation for a missing forty-one year old woman that walked away from her home west of Prairie Grove. It was found that she got in another vehicle and the search was cancelled.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In August 2015, 19 rural fire departments (56 firefighters) were provided wildland fire training. RFP received 4 Freightliners from Department of Defense (DOD). There were 3 Department of Defense (DOD) vehicles and 1 generator issued to VFDs.

The RFP shop completed maintenance on nine AFC vehicles and equipment.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 145 active Firewise communities. Recognized Firewise Communities display signs at the city limits.

In August, Firewise staff: assisted 31 communities with recertification efforts; delivered three introductory presentations about the Firewise program; presented one risk assessment training, met with 22 County Office of Emergency Management coordinators; provided educational material for 15 Firewise events, assisted 29 communities with application paperwork; met with the Arkansas Fire Boat School committee to review the 2015 school and start planning the 2016 training; attended the EMS conference; participated in Southwrap training; and, participated in a regional Firewise training webinar with personnel from across the region.

Firewise staff worked with Hot Springs Village to help resolve fuel loading issues in the community, visited with community leaders in the Eureka Springs area about the benefits of a continuing mitigation program, visited 21 AFC county and district offices to discuss Firewise programs in their area and met with 35 fire chiefs to provide information on Firewise.

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. In August, AFC Investigators and district law enforcement officers opened 6 timber theft, 7 fire, and 4 dumping cases.

AFC law enforcement officers conducted the county ranger annual law enforcement training for Districts 3, 5, 6, 7, and 8 this month. An AFC law enforcement officer conducted random breath alcohol tests for selected employees, and performed Air Attack duties several days during the month.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,779 landowners owning 877,972 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,303 Forest Stewards owning 281,785 acres.

For August, 15 FSP plans were prepared on 2,056 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 89 rural forestry management plans on 3,737 acres. AFC personnel conducted 10 prescribed burns on 351 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

Urban Forestry staff have been participating in the Green Infrastructure (GI) planning process with the City of Hot Springs. The concept for the plan arose from a GI workshop that was previously held in Little Rock, and is funded by a GI grant the Arkansas Forestry Commission received from the USFS. GI plans link multiple objectives together and show priorities.

The Hot Springs Green Infrastructure Landscape Study is a year-long effort, which began in April 2015, to map and catalog the highest valued natural assets of the City and create a plan for conserving or restoring them. Natural assets include trees, water, agricultural areas, trails, parks and habitat for wildlife. The project maps will also include significant cultural sites that depend on the landscape for their interpretation or protection such as, hot spring fountains or large historic structures or areas. The plan will identify key opportunities to make Hot Springs as clean and green as possible and to promote healthful lifestyles for residents and visitors. It can also be utilized to make the City more attractive to potential employers.

Forest Health: Along the drier ridgelines of central Arkansas, many hardwood species have started to turn red or brown. This is not a cause for alarm and this condition has occurred similarly in previous

years. Landowners may also notice their large hardwoods shedding leaves this September, and, in most cases, this is also a normal response to the recent dry weather.

In 2015, no southern pine beetle activity was reported anywhere west of the Mississippi River. Ips beetles activity has remained low as well. Approximately 70 percent of the gypsy moth traps placed by AFC have been checked, and no moths have been found.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15. Through the end of August there were 112 on line seedling orders. Seedling sales through the end of August resulted in 286,925 pine compared with 399,625 last year during the same period. There was a huge increase in regular hardwood sales compared with the same period as last year. Last year at this time the total hardwoods sold were 109,875. This year we have sold 1,390,400 through the end of August. There was also an increase in hardwood seedlings sold on contract. Last year we contract grew 1,200,000 hardwood seedlings for one nursery from Leland MS. This year we have one nursery from Crowville LA contract 1,200,000 and another nursery from Rayville LA contract 330,000 hardwood seedlings with AFC.

During August Baucum Nursery used a contract labor crew to help with weed control in addition to temp service contract and AFC labor from Baucum. Two AFC employees from Bluff City helped the nursery crew by applying herbicides and assisting with other cultural practices. A new nursery technician began work on August 3, but our nursery staff was still missing the auto/diesel mechanic position which was in freeze committee for half of June, all of July and all of August. The position was announced on August 28. It has been a tough summer trying to produce a crop of seedlings with 2 of 4 nursery labor positions vacant.

Two rounds of fertilizer, based on soil test recommendations by independent soil scientist who specializes in bare root tree seedling nursery production, were applied on all crops at Baucum during August.

Reforestation Manager formed a construction committee for a new pine packing house at Baucum Nursery: Committee members are, Chief Fiscal Officer, Assistant State Forester Management, Reforestation Manager and Nursery Manager. The committee had a preconstruction meeting with the Architectural Firm that was awarded the project. The existing pine packing house will be converted to a shop which will allow for more space in a new pine packing house and improved logistical flow of seedlings.

Mike Adcock from Cypress Brake Tree Farm in Rayville LA toured the nursery and inspected the 330,000 hardwood seedlings we are growing for him.

Reforestation Manager with the help and support of AFC Human Resources Manager changed the time sheet reporting procedure to insure that all time sheets are filled out correctly and submitted on time.

Tree Improvement: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

Tree Improvement staff did a lot of orchard maintenance in August. Trees were marked to be removed from the orchards. The Western Gulf Forest Tree Improvement Program (WGFTIP) makes recommendations based on genetic gain for all families in the orchard; which families should remain for seed production and which families should be removed. The objective is to keep only the best families even if we are not harvesting that particular family so that the pollen cloud will be from the highest genetic gain possible. Lower limbs on potted grafts were pruned and grafts were inventoried for planting in the orchards this fall. Began flagging trees for identification of families for cone harvest. All orchard trees were fertilized according to WGFTIP recommendations.

Reforestation Foreman began site prep for future progeny tests. The first seedlings to be planted at the new location are currently growing in the greenhouse. Deputy State Forester, Asst. State Forester Management, State Forest Manager, Reforestation Manager and Reforestation Foreman surveyed many locations on AFC state forest for possible progeny test sites. The best location was determined to be west of the improved shortleaf pine seed orchard.

Best Management Practices (BMP): AFC provides BMP training to loggers and timber companies; conducts courtesy exams prior to beginning, or during timber harvest operations; and, addresses logging complaints.

The BMP Coordinator conducted one courtesy exam in Conway County with 4 participants. The exam compared the Arkansas Forestry Commissions BMP Program to the harvest site. The BMP coordinator provided an overview of the entire program and offered technical assistance and training to help with the landowner's SFI program and audits.

The BMP Coordinator received two (2) complaints, both were found to be valid. The first complaint was located in Jefferson County, and the second complaint was located in Sharp County. Both complaints are being acted upon by the BMP Coordinator to mediate mitigation activity. Neither complaint has been referred to the Arkansas Forestry Association (AFA) or Arkansas Department of Environmental Quality (ADEQ).

The BMP coordinator participated in the Conway Lake Point Remove watershed meeting. The meeting's focus was to organize a leadership structure and mission statement. These would be the first steps in putting together an EPA watershed plan.

The BMP coordinator represented AFC and provided reports at the quarterly AFA Forest Practices Committee meeting.

The AFC BMP coordinator provided the BMP report for the State Implementation Committee meeting in Glenwood.

The BMP coordinator continues work with the Southeastern Partnership for Forests and Water Forum. The committee agreed to move forward with a joint public service announcement on the connection between forests and drinking water and the importance of healthy forests and water.

The BMP coordinator continues to work with the Southern Group State Foresters Water Resources Committee about the concerns of potential impacts from the 300 page rule of the WOTUS.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-

mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

For August, FIA personnel have measured and submitted data on 56 plots.
