During the second quarter of fiscal year 2016, the Arkansas Securities Department collected a total of \$73,638.90 in fines assessed from Consent Orders. Of the total amount of fines collected, \$13,638.90 was deposited to Special Revenue, Fund SIE0000, and \$60,000 was deposited to General Revenue. A listing of the orders by the case name with detail of the amounts collected is provided on the attached spreadsheet. During this period, there were no settlements or agreements that directed payments to third parties other than the consent order that directed restitution to be paid to the Arkansas consumers. Copies of the Orders are available on the Department's website at www.securities.arkansas.gov under the legal section.

Pursuant to the Arkansas Securities Act, fines paid for violations involving the Securities Act are deposited into the Investor Education Fund, until the balance reaches \$150,000. Securities Act fine money in excess of \$150,000 collected in any one year is designated as general revenues.

During the fourth quarter there were \$75,944.68 in expenditures from the Investor Education Fund. Expenditures included \$6,362.33 for promotional items; \$121.50 for travel reimbursement; \$76.30 for freight; \$16.35 for printing; \$37.53 for fuel for the state car; and \$69,330.67 for grants to 17 public schools and 1 non-profit organization. The Investor Education program made 8 presentations to approximately 374 persons throughout the state. The programs included presentations on Planning for Retirement that were directed to pre-retirees and state employees and training for teachers and school administrators about teaching investing basics.
