HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Prepared by: THE BUREAU OF LEGISLATIVE RESEARCH

Collections of Gross General Revenues year-to-date of approximately \$5,410.2 million have decreased \$12.8 million, or 0.2%, below the \$5,423 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$661.3 million increased \$37.3 million, or 6%, from the \$624 million available for distribution in April 2015. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,692,523.84 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$26,925,238.40.

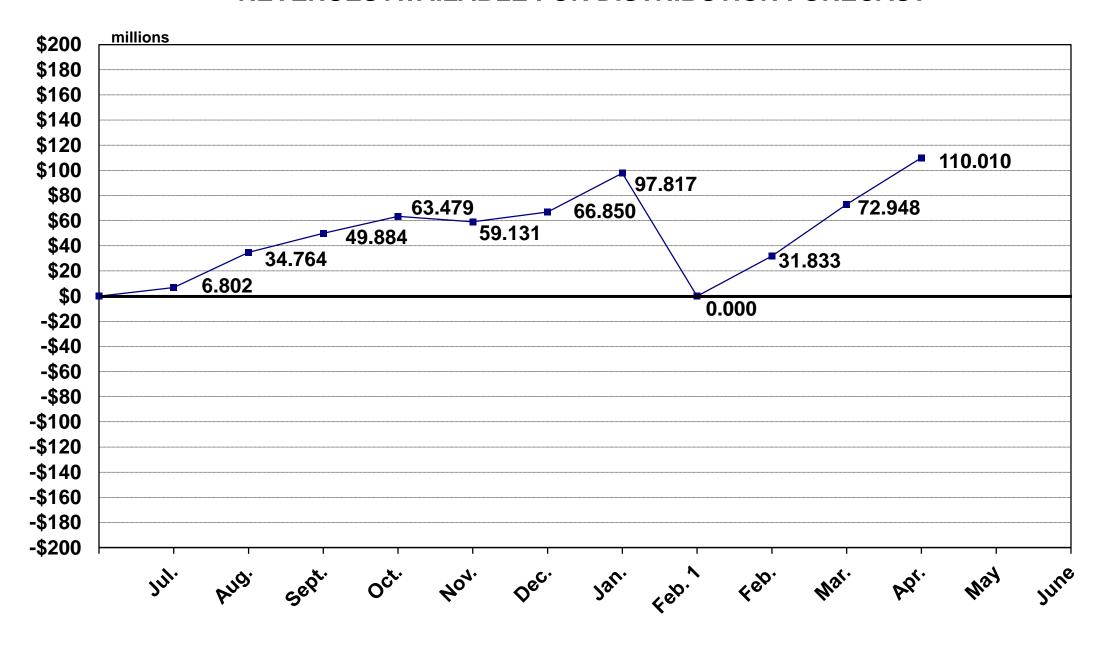
