Collections of Gross General Revenues year-to-date of approximately \$6,470 million have decreased \$52.2 million, or 0.8%, below the \$6,522.2 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$541.7 million decreased \$45.3 million, or 7.7%, from the \$587 million available for distribution in June 2015. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,692,523.84 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$32,310,286.08.

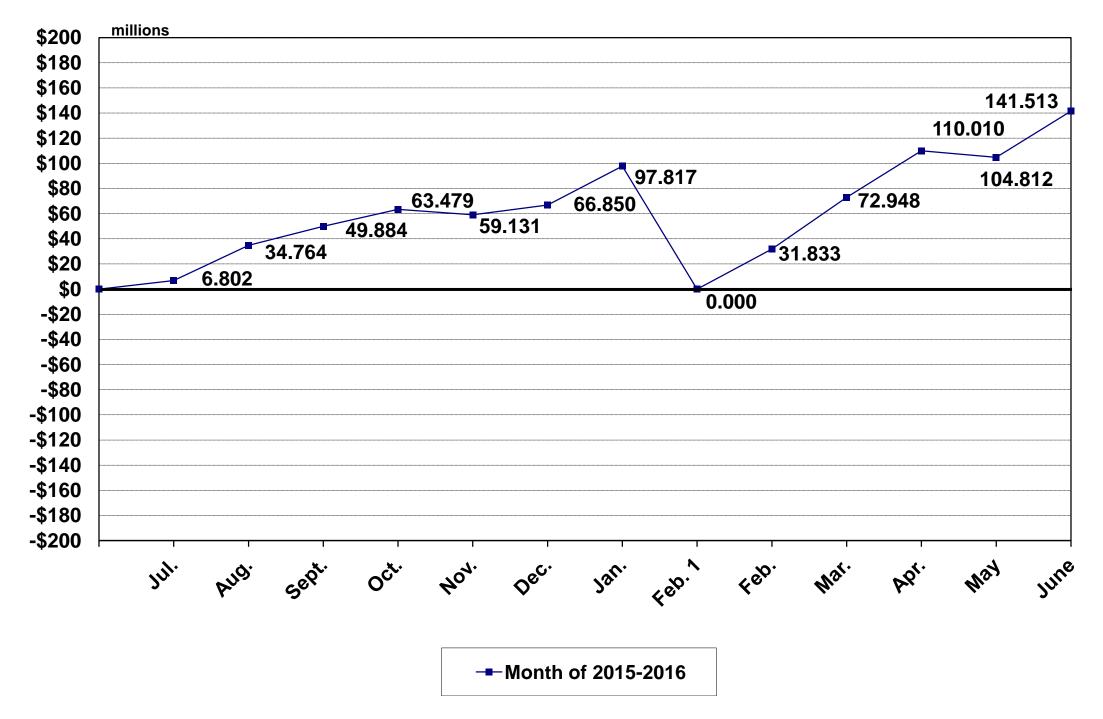
