Collections of Gross General Revenues year-to-date of approximately \$1,524.2 million have decreased \$1.8 million, or 0.1%, below the \$1,526 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$515.5 million decreased \$0.5 million, or 0.1%, from the \$516 million available for distribution in September 2015. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,543,399.02 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$7,630,197.06.


