HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,434.2 million have increased \$24 million, or 0.4%, above the \$5,410.2 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$660.9 million decreased \$0.4 million, or 0.1%, from the \$661.3 million available for distribution in April 2016. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,543,399.02 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$25,433,990.20.

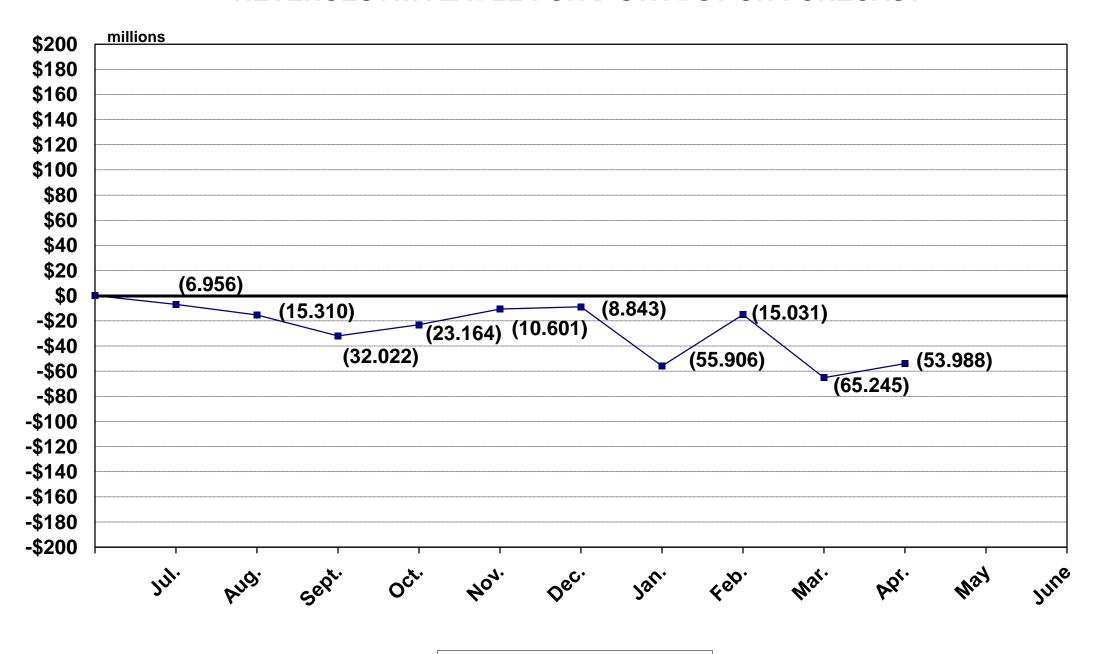
