On December 20, 2016, Senator Bill Sample and Representative David Branscum, Co-Chairs of the Legislative Council and Senator Bart Hester and Representative Jeff Wardlaw, Co-Chairs of Review Subcommittee received written notification from Larry Walther, DFA Director requesting review of a Technical and General Services (TGS) Contract.

Senator Hester and Representative Wardlaw,

Pursuant to Ark. Code Ann. § 19-11-233, the Department of Finance and Administration, Employee Benefits Division (EBD) requested my authorization to enter into a technical and general services contract with DataPath Administrative Services, Inc. (DataPath) I granted authorization for EBD to move forward with and emergency contract, finding that it was necessary to preserve the functional capability of the agency.

Under Office of State Procurement rules, an emergency technical and general service contract over one hundred thousand dollars (\$100,000) must be submitted to the Legislative Council.
