Enclosed is the third report required by Act 799 of 2003. The fines collected by the Commission from July 1, 2006 through June 30, 2007 totaled \$707,203.51. These funds were transferred to the Department of Education and then were distributed to the counties in October 2007. The counties are responsible for distributing these grant funds to schools or conservation districts for fish and wildlife conservation education programs.

The fines collected by the Commission from July 1, 2007 through June 30, 2008 totaled \$659,653.14. These funds will be transferred to the Department of Education in October 2008 for distribution to the counties. Our next report, for two years, will be submitted in September 2010.
