HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$3,925.6 million have decreased \$133.6 million, or 3.3%, below the \$4,059.2 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$285.2 million decreased \$14.3 million, or 4.8%, from the \$299.5 million available for distribution in March 2009.

In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$1,956,112.71 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$17,605,014.39.


