On March 24, 2014 I (Lt. L. Davis) was forwarded a sworn affidavit by Major W. Conner (CSO) that was written by inmate R. Bradford #078948. The subject of the affidavit written by inmate Bradford is "Report of Stolen Property." In the affidavit, inmate Bradford listed a Jenson Radio-battery operated AM/FM radio, (1) Silver Elgin Diamond watch, (1) sony clear radio and (2) Reebok, Nike White gym shoes as items that were confiscated or stolen by officers during a routine search of his cell on March 14, 2014. Upon receiving this information an investigation was initiated into the allegations made by inmate R. Bradford #078948. I (Lt. L. Davis) located a 401 form that was written on 3/14/2014 by Sgt. A. Wallace(officer who conducted search of March 14, 2014) which listed (4) altered headphones, (1) Silver watch (inmate possessed two), (1) altered ADC mat (1) clear tunes radio (No ADC# and inmate possessed more than one) as the items that had been confiscated. Sgt. Wallace was listed on the 401 form as the officer conducting the search. I (Lt. L. Davis) then located the confiscated property in connection with the 401 form (property was stored for Disciplinary court evidence). Upon viewing the property that was confiscated during a search of inmate Bradford cell on March 14, 2014 (date listed on Sworn affidavit) I found (4) pair of altered headphones (not mentioned on affidavit), (1) Sony radio (no ADC number, (40) loose pills and (1) Timex watch(Silver in Color). None of the items that inmate Bradford claimed were stolen or confiscated during the search of his cell were located in the confiscated property or placed on the 401 confiscation form. Inmate Bradford was written a disciplinary by Sgt. A. Wallace for possessing contraband that was found during search of his cell on March 14, 2014. On March 25, 2014 at approximately 9:33am, I (Lt. L. Davis) concluded this investigation and find that at no time did inmate R. Bradford # 78948 ever possess the items that he claimed were stolen or confiscated by officers during a search of his cell on March 14, 2014. Inmate R.
