SECTION 14. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BUFFALO RIVER WATERSHED MONITORING. The appropriation and funding provided by the legislature for Buffalo River Watershed Monitoring in this act shall be used for environmental studies related to monitoring swine farming operations within the Buffalo River watershed. The studies will be conducted on behalf of the Arkansas Department of Environmental Quality. The University of Arkansas - Division of Agriculture will report the results and progress of these studies to the House and Senate Public Health, Welfare and Labor committees by June 30th and December 31st of each year. It is intended by the 90th General Assembly that these studies be conducted for four fiscal years. concluding with the 2018-2019 fiscal year.
