The project includes three separate locations totaling 106.64 acres, near campus. The largest parcel at Cato Springs and Razorback Road (72.46 acres) accommodates most of the program including six flag-football/soccer fields, four softball fields, three basketball courts, and four volley ball courts, along with associated parking and lighting, a maintenance barn and restrooms. Two smaller parcels will be developed concurrently to accommodate three club sports field, tennis courts and parking.
