and covenants contained herein, and other good and valuable consideration, the receipt and adequacy of										
which are acknowledged, and intending to be legally bound, agree as follows:										

GENERAL PROVISIONS

- 1. **Sale.** BHDC agrees to sell, and Purchaser agrees to purchase, harvest, and remove the trees included in this contract subject to the provisions herein.
- 2. **Title to Trees.** All right, title, and interest in or to any tree included in this Contract shall remain vested in BHDC until the tree is severed by the purchaser, at which time title shall vest with the Purchaser. Any tree remaining in the sale area, whether cut or uncut, beyond the contract period shall be deemed abandoned by the Purchaser, and all right, title, and interest thereto shall revert to the Boonville Human Development Center.
- 3. **Force Majeure.** In the event any tree included in this contract is destroyed, damaged, or otherwise rendered unmerchantable by fire, wind, flood, insects, diseases, the intentional or negligent acts of third parties, or similar cause, the party holding title to the destroyed or damaged trees shall bear the loss in stumpage and required deposits resulting from such destruction, damage, or rendering of unmerchantability. BHDC shall have no obligation to supply, and Purchaser shall have no obligation to accept and pay for, other trees in lieu of those destroyed, damaged, or rendered unmerchantable. Notwithstanding any provision to the contrary, all damages and loss to trees removed from the sale area by Purchaser shall be borne by the Purchaser.
- 4. **Amendments.** All modifications or amendments to the terms of this Contract, including amendment of the Contract Price provided herein, shall be in writing
- 5. **No Assignment.** Neither party may assign or transfer their respective rights or obligations under the Contract without written consent of the other party. Any purported transfer or assignment without such consent shall be void. Subcontracting in the course of performance of this contract is permitted.
- 6. **Notice.** Unless otherwise provided in this Contract, all notices required herein shall be in writing and shall be deemed to have been duly given upon the date of delivery if delivered in person, upon the date postmarked if mailed, registered or certified, and upon the date sent if by electronic means, to the following representatives at their respective addresses:

- 7. **Sale Area.** This sale area of <u>65</u> acres, more or less, is located in <u>Logan</u> County(s) Arkansas. The boundaries of the sale area and any subdivisions thereof, are as shown on the attached sale area map or plat (Exhibit A).
- 8. **Sale Area Legal Description**. Section 18 of Township 5 North Range 27 West, and the harvest area is marked by placing three horizontal stripes of orange paint on trees. The paint marks are facing the interior of the unit and are visible at eye level on the trees. All the area contained inside of these marks is in the sale unit.
- 9. **Sale Objectives.** The objectives for the sale are: Removal of all non-marked timber. The area has been selected for a 29-acre seed tree harvest on half and 25-acre Oak- Pine Savanna harvest on the other half with natural regeneration so all timber should be removed except the marked seed trees. This stand has 11 acres of marked SMZs.
- 10. **Right to Convey.** BHDC represents and warrants it has full right to convey full title of the trees that are the subject this Contract.
- 11. **Description of Timber.** This stand is pine and mixed hardwood that has been marked for a natural regeneration treatment of 29 acres being Seed Tree harvest and 25 acres being Oak- Pine Savanna harvest. This stand has 11 acres of marked Streamside Management Zones throughout the stand. The trees to be left have been marked with an orange band at eye level and an orange mark at ground level.
- 12. **Estimated Tonnage.** Total advertised tonnage estimates are as follows;

265 MBF of Pine Saw Timber 19 MBF of Hardwood Saw Timber

The total advertised tonnage estimates are for informational purposes only, and BHDC makes no warranty or guarantee whatsoever, whether expressed or implied, as to the actual tonnage volumes estimated under this Contract.

CONTRACT PRICE AND PAYMENT

13. **Contract Price.** Purchaser agrees to buy, and BHDC agrees to sell, all forest products designated for removal under this Contract at a rate of \$ **X.00/ton**.

BONDING

- 15. Cutting and removal of trees in conformance with this Contract may commence and continue only after both parties execute this Contract and after submission and maintenance of all bonds, certificates, or statements required thereunder.
- 16. Prior to commencing operations at the Sale Area, Purchaser shall obtain an irrevocable letter of credit, cash deposit, or security bond (Bond) in a form acceptable to BHDC. The Bond shall contain, at a minimum, the following terms:
 - a. Value equal to ten percent (10%) of the total sale value;
 - b. Designation of BHDC as the sole oblige or beneficiary;
 - c. Terms authorizing BHDC to demand payment upon the bond for nonpayment or other damages arising from a breach of this Contract; and
 - d. Any additional reasonable terms deemed necessary or desirable by BHDC
- 17. Purchaser shall submit the Bond no later than fifteen (15) business days after contract execution and may only commence work upon written approval of the Bond by BHDC.
- 18. Purchaser shall maintain and keep the Bond active in its full amount at all times. Purchaser shall immediately suspend operations at the Sale Area in instances where the Bond is not active or fully funded and shall only resume upon cure of any defect in the Bond.

- 19. Failure to comply with the Bond requirements of this Contract shall be deemed a breach of the Contract and entitle BHDC to recovery for all damages and remedies available to it under the Contract and Arkansas law. Purchaser agrees and authorizes the BHDC to collect on the performance bond for payment settlement, damages, or Contract breach by the Purchaser. BHDC shall hold said performance bond pending final check and approval of harvest operations. Upon written notification of this contract completion by the Purchaser and after the final harvest approval, BHDC will return the deposit in full, less any money withheld as damages or for lack of compliance by the Purchaser with any provisions of this Contract.
- 20. The Bond shall be released by BHDC upon successful completion of all terms and obligations of the Contract by Purchaser. In its sole discretion, BHDC shall have the right to keep and draw upon the Bond at the end of the contract period in satisfaction of nonpayment or other breach by Purchaser.
- 21. Purchaser may provide a replacement bond, but Purchaser shall not terminate the original Bond until a replacement bond has been approved by BHDC in accordance with the terms of the Contract and the replacement bond has been executed by the issuing institution.

CONTRACT TERM

- 22. **Term.** The Contract term shall begin on the date that both Parties have signed the Contract (Contract Execution). Purchaser shall commence operations as soon as practical after the prelogging conference described in paragraph 36. Purchaser shall remove all trees designated for harvest on or before __10/31/2023_____. If, due to circumstances beyond control of Purchaser, an extension of the time limit is necessary, BHDC may in its sole discretion and upon written request by the Purchaser, grant an extension of the contract period. Additional extensions may be granted in the sole discretion of BHDC if Purchaser demonstrates conclusively that it has vigorously prosecuted the work without undue delay, and failure to harvest and remove all trees covered by the Contract within the specified time is due to reasons beyond Purchaser's control and without Purchaser's fault or negligence.
- 23. **Suspension of Term.** BHDC may temporarily suspend operations under this Contract due to: excessive property damage; wet conditions; identification of natural, cultural, or other resources needing special protection; a court order or other legal sanction; or for any other reason upon notice to the Purchaser or other persons operating on the Sale Area under this Contract. BHDC may extend the Contract Period in an amount deemed reasonable by BHDC.

PURCHASER INSURANCE AND LIABILITY

- 24. **Proof of Insurance.** The Purchaser and subcontractors shall conform to the requirements of the Arkansas Workers' Compensation Law, Ark. Code Ann. § 11-9-101 et seq., and all other applicable state and federal laws, in the performance of the Contract. Purchaser shall provide BHDC with proof of liability insurance immediately upon execution of the Contract.
- 25. **Logger Training.** Purchaser shall provide documentation of logger training or certification immediately upon execution of the Contract.
- 26. **Indemnification.** Purchaser hereby assumes all risks of damage or injury to persons or property arising from or in connection with the Contract. Purchaser shall indemnify, defend, and hold

harmless BHDC, the State of Arkansas, and their officers, agents, and employees for any claims arising from or in connection with Purchaser's performance under the Contract.

DAMAGE TO BHDC PROPERTY

- 27. **Liquidated Damages.** Purchaser shall not cut or damage undesignated trees. Negligent, willful, or unauthorized tree cutting is likely to cause substantial silvicultural or other damage to the residual stand. In such instances of breach, it will be difficult, if not impossible, to determine the precise amount of such damage. Therefore, Purchaser shall pay as liquidated damages, and not as a penalty, an amount equal to three times the stumpage price for each damaged or cut tree that is not designated for cutting by the Contract. In its sole discretion, BHDC may leave damaged trees standing or designate it for cutting and removal.
- 28. **Site Preparation.** Purchaser shall not remove undesignated trees to prepare a loading site, temporary road, or banking site, without prior approval from BHDC, which shall not be unreasonably withheld. Upon approval, BHDC shall mark those trees with tree marking paint prior to cutting. BHDC shall be entitled to liquidated damages as provided in Paragraph 27 for any undesignated trees cut without prior approval.
- 29. **Accidental Cuts.** In instances where Purchaser cuts or damages undesignated trees that meet utilization standards by mistake and without negligence, then such trees shall be cut and removed at the stumpage price set as set forth in the Timber Being Sold Table. BHDC shall establish rates to be paid for undesignated trees not listed in the Timber Being Sold Table. Trees cut and not promptly removed in a green condition shall be paid for at an average "green weight" load, at the contract stumpage price when it is removed.
- 30. **Damage to Certain Trees.** Purchaser will not cut or injure any witness trees, monuments, or tree reproduction, except such minor injury and damage as is necessary under normal and careful harvest procedures, see Appendix A. BHDC will determine the extent of damages (examples: bark skinned off trees, broken leave trees, excessive rutting or pollution) and the amount of any damage deemed excessive or unnecessary and will notify Purchaser in writing of the weight and dollar figures of damage done.
- 31. **Excessive Rutting.** Purchaser shall not engage in excessive rutting, which is defined as rutting that is 8" deep or more across 30% or more for 100 feet or more.
- 32. **Excessive Residual Tree Damage.** Purchaser shall not cause excessive residual tree damage, which is defined as damaged crowns, bark stripping (cat-facing), and root depredation that affects more than 10% of the residual stand.
- 33. **Excessive Pollution.** Purchaser shall not cause excessive pollution, which is defined as leaving any trash of any kind at the end of a work day (including trash of any kind left overnight) or any equipment fluids spilled or leaked that BHDC deems to negatively impact the current or future vegetation at the site of spill or surrounding area. Purchaser shall not leave any trash behind such as oil cans, hoses, or tires and shall remove such trash daily.

RIGHT TO CURE

34. **Right to Cure.** Should BHDC determine that Purchaser has breached a condition or term of this Contract, BHDC shall send Purchaser a notice (invoice or request an equitable remedy) via

registered mail. Purchaser shall have ten (10) business days to cure any breach. Evidence establishing that a breach by Purchaser has been cured must be received by BHDC within ten (10) business days of receipt of notice of breach provided by BHDC.

DISPUTES RESOLUTION

35. **Dispute Resolution.** Upon failure to reach an agreement in any dispute as to interpretation of the Contract, a final decision rendered by the Arkansas State Forester shall prevail. The final decision by the Arkansas State Forester shall not preclude the Purchaser from thereafter pursuing remedies available under Arkansas law. The Parties acknowledge and agree that the final decision of the Arkansas State Forester shall not be subject to the Arkansas Administrative Procedure Act, Ark. Code Ann. § 25-15-101 et seq.

HARVESTING

- 36. **Conferences.** The Parties shall confer before harvesting begins to discuss logging plans or any other phases of the harvest operation and at any other time upon written request by one party to the other.
- 37. **Right to Inspect.** The BHDC reserves the right to inspect harvest operations at any time to determine whether Purchaser is meeting the provisions of the Contract.
- 38. **Ingress and Egress.** Purchaser shall have free ingress and egress over BHDC property to the sale site. Securing rights of ingress and egress over adjoining property not owned or controlled by the BHDC shall be the sole responsibility of Purchaser.
- 39. **Use of Roads.** Purchaser shall use existing roads and trails wherever practicable. Purchaser may erect, on BHDC-controlled land, roads or other improvements necessary in the harvesting of trees included in this contract provided, however, that the BHDC approves the plans and locations in advance and complies with the terms of the Contract in the course of performance.
- 40. **Best Management Practices.** Purchaser shall comply with "Arkansas Forestry Best Management Practices for Water Quality Protection" (BMPs) during all harvesting operations of this sale. Arkansas BMP's can be found on the Arkansas Department of Agriculture's website or by following this link;

https://www.agriculture.arkansas.gov/wp-content/uploads/2020/05/bmpbookrevisedea.pdf

- 41. **Restrictions on Heavy Equipment.** Heavy Equipment and all vehicles are prohibited within Streamside Management Zone (SMZ) boundaries shown on the Sale Map and marked by placing three horizontal stripes of Green paint on trees along SMZs. The paint marks are facing the interior of the unit and are visible at eye level on the trees. All crossings of Streamside Management Zones, skid trails and temporary roads, must be approved by the BHDC.
- 42. **Logger Training.** Purchaser shall use a logging contractor that has completed the Arkansas Pro Logger training program or has a comparable certificate of training that complies with the training recommended by the Sustainable Forestry Initiative.

- 43. **Roads and Other Sites.** Purchaser and BHDC shall agree to locations of any temporary roads, loading sites, skidding on (over/on/across) permanent roads or other work activities that have a potential to impact soil erosion **before** the action begins. Purchaser shall block vehicle access and effectively water-bar all temporary roads and skid trails immediately upon completion of use. Purchaser shall notify the State Forest Foreman or State Forest Manager upon completion.
- 44. **Suspension of Operations.** BHDC reserves the right to halt harvest operations on all days and on any portion of the Sale Area when wet ground conditions may cause equipment to excessively damage the land without any obligation to compensate Purchaser. If soil disturbance occurs, the Purchaser agrees to work cooperatively to mitigate and repair, at Purchaser's expense, any and all instances of excessive soil disturbance to meet BHDC's satisfaction.
- 45. **Duty to Protect.** Purchaser shall protect property including but not limited to land survey monuments, roads, fences, utility lines, ditches, bridges, and other constructed structures or improvements, against unnecessary injury and shall repair damaged property caused by Purchaser by restoring such damage immediately to the condition found prior to damage.
- 46. Purchaser is responsible for all tools, equipment, and property of every kind used in the harvest operation. Purchaser shall remove all tools, equipment, and all other temporary improvements placed on the premises by him to the satisfaction of BHDC before expiration of the Contract.
- 47. **Merchandising.** Purchaser will merchandise all trees, including tops, to the lowest possible diameter for commercially salable products.
- 48. **Wildfire.** Purchaser shall notify BHDC immediately if wildfire occurs, regardless of whether the cause of the wildfire is known. Purchaser shall take reasonable care to prevent its operations from causing wildfire and shall use its employees and equipment to suppress any wildfires on the Sale Area. The Purchaser shall keep a fire extinguisher in all rolling equipment and a shovel or fire rake on the job site. Purchaser is responsible for damages from all fire damage arising from its actions or actions by its employees or agents and will compensate BHDC for all resulting damages and costs of fire suppression. BHDC reserves the right to limit or restrict Purchaser operations at the Sale Area during period of critical fire weather.
- 49. **Wildlife Food Plots.** Purchaser shall keep wildlife food plots free of logging operations. Loggers will fell trees along plot boundaries, so the plot is free of tops and debris. No equipment is to cross plots except on existing trails.
- 50. **Equipment Sanitation.** Purchaser shall thoroughly clean equipment prior to moving onto the Sale Area when moving from an area known to contain invasive species that are not present on the Sale Area.
- 51. **Protection of Certain Resources.** Purchaser shall take all measures necessary to protect known special resource areas identified on Sale Map or on the ground. Special resources include cultural resources, wildlife, and botanical resources. These resource locations and protection measures will be discussed at a pre-work conference with the Purchaser. If a tree inadvertently falls into a protected area, it shall not be removed without approval by BHDC. If the Purchaser discovers an area needing special protection, the purchaser will discontinue operations in the immediate area and notify BHDC.
- 52. **No Discrimination.** Purchaser shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin.

Boonville Human Development Center of Arkansas TIMBER SALE CONTRACT ADDENDUM

GUIDELINES FOR WATER BARS

Water bars act to divert side ditch and surface runoff, which minimizes erosion, and provide conditions suitable for revegetation. The Division may designate location.

Construction

- 1. Water bars should be placed at a slight angle to the road, firebreak or skid trail. The water bar slows the water, promotes deposition of sediment in the water, and then allows the water to slowly exit the road with minimal washing. The greater the percentage of slope, the less the angle of the water bar should be to the road surface.
- 2. Stabilizing the water bars at construction will prevent additional erosion. See Table 1.
- 3. The following table is a guide for spacing between water bars:

Grade of	Distance
Road	Between
(Percent)	Water Bars
	(Feet)
2	250
5	135
10	80
15	60
20	45
30	35

- 4. To fully intercept any ditch flows, the uphill end of the water bar should extend beyond the side ditch line of the road and tie into the cut bank blocking the ditch.
- 5. The outflow end of the water bar should be fully open and extend beyond the edge of the road or trail to safely disperse runoff water onto the undisturbed forest floor.
- 6. Requirements for effective water bar construction on forest roads, trails and firebreaks are site specific so construction should match existing soil and slope conditions.

- 1. Pine saw timber: Minimum Dbh 9.1"; minimum top end diameter 7.0" or merchantable height.
- 2. Pine pulpwood from tops: minimum top end diameter 3.0" or merchantable height.
- 3. Pine pulpwood tree length: Minimum top end diameter 3.0" or merchantable height.
- 4. Hardwood pulpwood tree length: Minimum top end diameter 4.0" or merchantable height.

METHOD OF DETERMINING WINNING BIDDER FOR PAY AS CUT SALES

A total estimated bid price will be calculated by Arkansas Department of Agriculture-Forestry Division for each bidder, based on the prices per ton and top end diameters submitted.

- 1. Pine saw timber method: For each 1.0" increase in top end diameter above the State Forest marking guideline of a 7.0" top, estimated tons of pine saw timber to be hauled will be decreased by 1.25% from advertised tonnages.
- 2. Pine pulpwood from tops method: The assumption will be made that for every 6.5 loads of pine saw timber hauled (including any pine hauled as poles), there will be 1 load of pine pulpwood from tops (with a 3" top end diameter, or merchantable height). For each 1.0" increase in top end diameter above the State Forest marking guideline of a 3.0" top, estimated tons of pine pulpwood to be hauled will be decreased by 0.25% from the 6.5 to 1 tonnage assumption above. For each 1.0" decrease in top end diameter below the State Forest marking guideline of a 3.0" top, estimated tons of pine pulpwood to be hauled will be increased by 0.25% from the 6.5 to 1 tonnage assumption above. Each load is assumed to weigh 28 tons.
- 3. Tree length pine pulpwood method: For each 1.0" increase in top end diameter above the State Forest marking guideline of a 3.0" top, estimated tons of tree length pine pulpwood to be hauled will be decreased by 1.0% from advertised tonnages. For each 1.0" decrease in top end diameter below the State Forest inventory guideline of a 3.0" top, estimated tons of tree length pine pulpwood to be hauled will be increased by 1.0% from advertised tonnages.

- 4. Hardwood saw timber method: For each 1.0" increase in top end diameter above the State Forest Marking Guideline of a 10.0" top, estimated tons of hardwood saw timber to be hauled will be decreased by 1.25% from advertised tonnages. For each 1.0" decrease in top end diameter below the State Forest Marking Guideline of a 10.0" top, estimated tons of hardwood saw timber to be hauled will be increased by 1.25% from advertised tonnages.
- 5. Hardwood pulpwood method: For each 1.0" increase in top end diameter above the State Forest marking guideline of a 4.0" top, estimated tons of hardwood pulpwood to be hauled will be decreased by 1.0% from advertised tonnages. For each 1.0" decrease in top end diameter below the State Forest inventory guideline of a 4.0" top, estimated tons of hardwood pulpwood to be hauled will be increased by 1.0% from advertised tonnages.
