Dear Co-Chairs:

Under Arkansas Procurement Law, when the General Assembly is in session, non-exempt contracts for services must be presented for legislative review if they have an annual contract amount that equals or exceeds fifty thousand dollars (\$50,000) in any one (1) contract year or a total projected contract amount of three hundred fifty thousand dollars (\$350,000) over the term of the contract. See Ark. Code Ann. § 19-11-265.

The Department of Transformation and Shared Services, through its Office of State Procurement, has reviewed the contracts that it submitted to the JBC – Peer Review Subcommittee for review in May. All of them appear, on their face, to be lawful contracts. Should you have any questions, we will do our best to answer them.
