Dear Senator Flippo and Representative Davis:

The University of Arkansas at Fort Smith requests the suspension of the Committee Rules for Supplemental Agenda Item requiring submission in advance of a committee meeting to review the attached Technical & General Services contract between UAFS and Chartwells Dining Services.

The request to review this TGS contract is needed as students are returning to campus next week and a fully negotiated contract has been delayed, due mostly to the COVID epidemic, and partially due to the unexpected departure of our Vice Chancellor of Finance and Administration in July.

A Request for Proposal was issued January 23, 2020 for Campus Dining, Food Court, & Catering Services for the UAFS campus. After a lengthy review process, an award was made to Chartwells rather than the incumbent vendor. However, by then, Chartwells found themselves needing to rewrite 800+ contracts nationwide due to COVID-related addenda, and a full negotiation of terms on new contracts was not attainable. Since putting food service on hold for our students was not an option, both parties agreed to enter into a Letter of Intent given the short timeframe available, and to begin negotiating terms for the full contract.
