DHS REALLOCATION OF RESOURCES REQUEST #2 OF 4 FY2023 November PEER

This is the second request by the Department of Human Services for Reallocation of Resources, from a limit of four annually. Section 11(c) of Act 193 of 2022 allows transfer authority to DHS and sets limits for the number of requests, dollar amounts of the total requests, and the purpose for which requests can be submitted.

SECRETARY'S OFFICE

The Secretary's Office (SO) is requesting to transfer 3 positions from the following divisions to better serve within the department's shared administrative offices:

- 1 position from the Division of Child Care and Early Childhood Education;
- 1 position from the Division of County Operations; and
- 1 position from the Division of Medical Services.

The Secretary's Office is also requesting the following appropriation transfers within the Operation appropriation:

- \$261,950 from Professional Fees to Capital Outlay to purchase servers and computer hardware; and
- \$100,000 from Professional Fees to Extra Help to support administrative needs.

The Secretary's Office is also requesting to transfer \$3,738,597 in general revenue funding to support client needs and services from the following divisions:

- \$11,608 from the Division of Aging, Adult, and Behavioral Health Services;
- \$131,252 from the Division of Child Care and Early Childhood Education;
- \$2,798,644 from the Division of Children and Family Services;
- \$58,426 from the Division of County Operations;
- \$345,367 from the Division of Developmental Disabilities Services:
- \$367,328 from the Division of Provider Services and Quality Assurance; and
- \$25,972 from the Division of Youth Services.

DIVISION OF AGING, ADULT, AND BEHAVIORAL HEALTH SERVICES

The Division of Aging, Adult, and Behavioral Health Services (DAABH) is requesting the following appropriation transfers to their Operations appropriation. The requested transfers are needed to cover expenses for the Arkansas State Hospital and Adult Protective Services:

- \$1,100,000 from the Alcohol and Drug Abuse Prevention appropriation to Operating Expenses;
- \$25,000 from the Alcohol and Drug Abuse Prevention appropriation to Conference and Travel;

DIVISON OF CHILD CARE AND EARLY CHILDHOOD EDUCATION

The Division of Child Care and Early Childhood Education (DCCECE) is requesting to transfer \$36,000 in appropriation from Operating Expenses to Capital Outlay in their Commodity Distribution and Salvage appropriation for the purchase of two vehicles.
