This letter supplements Secretary Preston's letter to you of December 8, 2022 concerning recommended ARC grant projects to be approved by PEER at its December 13, 2022 meeting.

Following the transmittal of Secretary Preston's letter, some questions have arisen concerning six of the proposed project awards. To be certain that we have provided the committee with accurate information for the projects in question, we have removed these projects from the recommended project list so that they may be reviewed more closely by the State Broadband Office. Accordingly, attached is a revised list of fourteen projects totaling \$93,892,885 in requested grant funding.
