The Arkansas Department of Energy & Environment – Oil & Gas Commission is requesting a continuation of appropriation authorized under Section 33 of Act 796 of 2023, in the amount of \$995,000, for FY24. This appropriation will allow OGC to purchase a replacement HVAC system.

The HVAC mechanical systems consist of closed loop hot/cold water systems. The original equipment that remains is now approximately 36 years old. The chiller was replaced in 2001, and the two primary air handler units and a boiler were replaced during a 2012 HVAC upgrade. The boiler was replaced again in 2022 due to continued failures; however, the smaller components are original equipment and are causing reoccurring heating problems.

The normal life expectancy is about 20 years on a similar HVAC system. OGC has determined it should replace the equipment and other components on the heating side of the system. A professional engineering (PE) firm previously recommended OGC replace the chiller as well.

The Arkansas Department of Agriculture respectfully requests your approval for one-time, temporary appropriation in the amount of \$177,800 for FY2024 to provide funding to fairs, youth expos, and livestock shows across the state. Amendments to the line-item distribution language currently in Section 37 of the Department's appropriation bill, SB83, is needed to address changes discussed by legislators that were not completed during the legislative session.

The draft appropriation language below is intended to serve as a starting point for discussion so the legislature can decide on the appropriate funding distribution. Background information about funding to fairs is also provided below. Attached is the amount of funding each entity would receive if the draft appropriation language is approved and the level of funding remains the same as last year, \$724,272.

Draft Language

Background

Since at least the 1970s, the state of Arkansas has provided funding to fairs. Funding consists of (1) general revenue funding each year with funding distribution occurring as appropriated in the Department of Agriculture's annual appropriation bill and (2) capital improvement project funding every other year through the Development Enhancement Fund.

Prior to 2021, funding for fairs was based on an outdated and burdensome premium point system that was created in the early 1970s. This funding system was very restrictive, inflexible, and time consuming. Each year the Department of Agriculture would spend thousands of hours at county and district fairs checking animals, calculating and confirming points for exhibits, and chasing down documentation throughout the entire state.

Act 700 of the 2021 legislative session eliminated the rules for the premium point system that allowed fairs more control over how funds received could be utilized. Act 700 also eliminated the required admission surcharge fee in order to allow fairs to retain more of their funding.

While Act 700 of the 2021 legislative session helped address many issues, it was the Department of Agriculture's appropriation bill (Act 918 of the 2021 session) that removed funding to the High School Rodeo Association, District Junior Livestock Shows, District Livestock Shows, 4H, FFA, and Miss Arkansas Rodeo. Removing these entities from the Department's appropriation bill resulted in an increase in funding to county fairs and has led to the desire amongst several legislators to reconsider the entities and amounts of funding to be distributed from general revenue.
