Dear Secretary Walther,

I am writing to follow up with you in requesting the release of land-grant matching funds to the University of Arkansas at Pine Bluff for fiscal year 2023-24. During the Regular Session of the 94th General Assembly, the members appropriated \$2 million for the "UAPB Land Grant Set-Aside" in Act 561 Section 3 (15), which had the strong support of Governor Sarah Huckabee Sanders.

As you are aware, UAPB was designated a land grant institution in 1890. Congress authorizes funding for state land-grant universities for research and extension in the agriculture industry. Years ago, Congress mandated that states provide matching funds for those federal appropriations. The federal funding and state matching funds make it possible for UAPB to carry out a very important part of its mission—outreach and extension. With these funds, UAPB is able to assist the agriculture needs of Arkansans across the state, giving special attention to the aquaculture industry and to small and minority farmers.

This funding is much needed to help sustain the Aquaculture and Fisheries Center of Excellence, which supports the aquaculture industry and is recognized as a leader in aquaculture/fisheries teaching, research and extension programs. It is the only comprehensive aquaculture program within the University of Arkansas System to combine resident instruction, research, and extension responsibilities into one comprehensive unit. Moreover, the UAPB Sweet Potato Seed Program, which helps Arkansas farmers boost their yield by allowing them to plant first generation slips (transplants), is substantially supported by the funds.

We are grateful to Governor Sanders and the legislature for their support of our university and the landgrant matching funds that aid in covering the unmet portion of the state's matching funds for UAPB for 2023-24.

As authorized in Act 561 of 2023 Section 3(a)25 the Arkansas Department of Finance and Administration Disbursing Officer respectfully requests \$2,500,000 be released from the Drug Task Force Set-Aside and be transferred to the Miscellaneous Agencies Fund for State Drug Crime Enforcement and Prosecution Grant awards (HUA0154).

Annual disbursements from DFA-IGS for the Drug Task Forces (DTFs) total \$3.64M. The DTFs are supported using a combination of federal and state dollars, including the Drug Crime Assessment Fee special revenue fund.

The federal JAG grant covers approximately 48% of the total disbursements; the remainder is provided from state funds. Because access to the federal grant occurs later in the calendar year, this affects the flow of funds to the DTFs.

The state set-aside of \$2.5M appropriated in Act 561, will greatly alleviate the strain by making the funds available timely for distribution. The set-aside along with the special revenue fund and the \$1M in state match dollars will allow for advancement of funds quarterly to the DTFs based on their annual budget. The DTFs will be required to provide quarterly reporting of their expenditures for reconciliation.

Dear Secretary Walther:

The Arkansas Insurance Department (AID) respectfully requests a transfer of \$6,302,497.57 from the Restricted Reserve Fund – EBD or Contingency Set Aside, pursuant to the provisions of Act 561 of 2023, Section 3(19).

AID will utilize the restricted reserve funding to partially offset the increased property insurance premiums for school districts in the insurance program managed by the Arkansas School Boards Association (ASBA). One hundred seventy (170) school districts participate in the ASBA insurance program.

The same negative factors affecting the Arkansas Public School Insurance Trust program - addressed in my separate letter to you today - are also impacting the ASBA program, resulting in increased FY 2024 premiums of approximately \$21 million, or 114%. The transfer from restricted reserve would result in the increased premiums being shared 70/30 by the school districts and the state.

The attached worksheet provides the detailed amount of assistance that will be provided on behalf of each school district in the ASBA program. The assistance will be the remitted by AID to the ASBA, which will in turn remit payment to the insurers for the benefit of each district. In the event a district has already paid its premium in full, the assistance will be paid by AID directly to the school district.

Dear Secretary Walther:

The Arkansas Insurance Department (AID) respectfully requests a transfer of \$4,465,275.85 from the Restricted Reserve Fund – EBD or Contingency Set Aside, pursuant to the provisions of Act 561 of 2023, Section 3(19).

AID will utilize the restricted reserve funding to partially offset the increased property insurance premiums for school districts in the Arkansas Public School Insurance Trust (APSIT), which is managed by AID. Sixty-eight (68) school districts participate in ASPIT.

Due to a convergence of factors – poor claims experience, difficult conditions in the insurance marketplace, and a negative outlook from weather models -the premiums billed to school districts participating in APSIT will increase approximately \$15 million, or 154%, in FY 2024. The transfer from restricted reserve would result in the increased premiums being shared 70/30 by the school districts and the state.

The attached worksheet provides the detailed amount of assistance that will be provided on behalf of each school district in the APSIT program. The assistance will be remitted by AID directly to the APSIT insurers. In the event a district has already paid its premium in full, the assistance will be paid by AID directly to the school district.

The Arkansas Insurance Department (AID) respectfully requests a transfer of \$117,928.08 from the Restricted Reserve Fund - EBD or Contingency Set Aside, pursuant to the provisions of Act 561 of 2023, Section 3(19).

AID will utilize the restricted reserve funding to partially offset the increased property insurance premiums for the Bentonville School District, which procures insurance directly through the open market, rather than through the programs administered by the Arkansas Insurance Department or the Arkansas School Board Association. Bentonville has experienced the same insurance difficulties as those affecting other school districts, resulting in increased FY 2024 premiums of approximately \$393,000, or 50%. The transfer from restricted reserve would result in the increased premiums being shared 70/30 by Bentonville and the state. The assistance will be remitted directly by AID to the Bentonville School District.
