# Arkansas Attorney General Quarterly Report Pursuant to Act 763 of 2013 Period 07/01/2023 to 09/30/2023

# CASE NAME AND BRIEF DESCRIPTION OF COURT ORDERS OR SETTLEMENT AGREEMENTS

#### • Grand River Enterprises

State of Arkansas v. Grand River Enterprises - The Attorney General worked with Grand River to obtain a Settlement Agreement for Arkansas Assurance of Voluntary Compliance for its not complying with Arkansas's tobacco statutes.

#### Jean Butler

Jean Butler facilitated a multi-million dollar international sweepstakes scheme. Ms. Butler received funds from victims of the scam and funneled money to operators of the scheme in Jamaica.

#### Real Travel, LLC

State of Arkansas v. Real Travel, LLC; Bart Bowe; and Brian Scroggs - Real Travel entered into a Consent Judgment with the Attorney General for violations under the Arkansas Deceptive Trade Practices Act. Defendant is permanently restrained and enjoined from conducting any and all business related to timeshare and timeshare exit industries in the State of Arkansas.

#### Matthews Construction, LLC

Eric Matthews, a contractor, operated under various company names including Matthews Construction, LLC, and Arkansas Decks and More. Mr. Matthews violated the Arkansas Deceptive Trade Practices Act by soliciting large deposits before failing to complete, or sometimes even begin, the work he promised.

#### Ramona Turner McGee (pyramid scheme)

Ramona Turner McGee recruited individuals to join in Blessing Looms boards for like-minded individuals to receive more money than initially invested. Ramona Turner McGee collected thousands of dollars from Arkansas consumers operating an illegal pyramid scheme which harmed Arkansas consumers.

# Cedric X. Bunn and Xavier Raino d/b/a Best Ride Auto Sales

Lawsuit was filed in 2021 against Cedric Bunn and Xavier Raino, the owners and operators of Best Ride Auto Sales in Sherwood. The complaint alleges the used car dealership failed to deliver vehicle titles to consumers at the time of the sale, as required by law. The company violated the Arkansas Deceptive Trade Practices Act, the Used Motor Vehicle Protection Act, and the Motor Vehicle Administration, Certificate of Title, and Antitheft Act.

#### Cardinal Health, Inc., McKesson Corp., AmeriSourceBergen Drug Corp.

Opioid distributors have the responsibility of ensuring that medications are only distributed and dispensed to appropriate patients and not diverted to unauthorized users. These distributors failed to monitor, detect, investigate, refuse, and report suspicious orders of opioids, ultimately contributing to and creating a national and statewide emergency. Funds are restricted by the opioid Distributors Settlement Agreement and must be used to remediate the harms caused to Arkansans by the opioid epidemic and to prevent further damages from occurring.

# Indivior (Suboxone (Buprenorphine Hydrochloride and Naloxone)) Antitrust Litigation

This is a multistate antitrust lawsuit against Indivior for its anticompetitive conduct relating to the drug Suboxone. Indivior worked to intentionally keep generics from entering the market.

#### Adore Me, Inc.

This investigation of complaints about Adore Me's marketing and promotion of its VIP Membership program and the difficulty experienced by consumers when they tried to cancel their memberships. The states' investigation found that Adore Me deceptively marketed its VIP Membership Program and failed to disclose that consumers would accumulate store credit in lieu of an actual refund.

# Neill Reed/Jeric Goodrum

Reid and Goodrum used a deceased notary to quitclaim tax delinquent property to themselves after searching State Land Commissioner records. Many of the property owners were also deceased or elderly.

# Ideal Image of Group of Arkansas, PLLC

The business was under review from April 22, 2020 until September 17, 2020 for problematic business practices consisting primarily of charging consumers for services and not having availability for dates to provide the services or cancelling the services and not rescheduling after consumers have paid for the services. The investigator suggested on September 15, 2020 that our office either "open the investigation [and] move forward, or close the Target Review at this time and monitor for further complaints." Our office decided to monitor the business for further complaints of problematic business practices. Our office has received 7 complaints against the target for the same problematic business practices since being monitored. Formal investigation was reopened in 2022.

# Kristy Schneider

Kristy Schneider, from Saline County, wrongfully misrepresented that her minor child was deathly ill which resulted in over \$31,000 in charitable contributions and assistance from Arkansas consumers, organizations, and law enforcement agencies. Mrs. Schneider falsified her child's health condition to medical providers and lied to the general public in order to provoke an outpouring of well wishes, which often resulted in donations.

# • Laura Anne Jones (Purple Hat Construction)

Purple Hat Construction, LLC, is a home improvement business that kept consumers' payments without completing the work in violation of Arkansas Deceptive Trade Practices Act. During 2020 complaints were received that funds had been taken by Purple Hat Construction for projects that were never completed or even started. The business did not indicate when the work would be completed.

#### Hartsville Health & Rehab (East AR Health System)

The suit alleges that the former Cherokee Village hospital violated the Personal Information Protection Act (PIPA) and the Arkansas Deceptive Trade Practices Act (ADTPA) when the hospital abruptly closed its doors, locking out employees and abandoning patient and employee files. Eastern Ozarks Regional Health System failed to provide proper disposal or proper security for the documents prior to the properties being conveyed to the State of Arkansas. The hospital and its owners face civil penalties up to \$10,000 for each violation of the PIPA and the ADTPA.
