Dear Secretary Hudson,

The Arkansas Game and Fish Commission is requesting a transfer of \$6,500,000 from the Restricted Reserve Fund Game and Fish Grants Set-Aside authorized in Section 3(20) of Act 561 of 2023. This funding will be used to both accelerate several projects across the state and maximize federal funding, including the following:

- \$1,000,000 for Lake Wilhelmina renovations. Lake Wilhelmina is a legacy fishery in an underserved portion of the state.
- \$2,000,000 for the Glaise Creek Green Tree Reservoir restoration project. Glaise Creek has been the Commission's first-ever Green Tree Reservoir restoration project and is scheduled to be completed at the end of FY2024 or the beginning of FY2025.
- \$2,000,000 for Centerton Hatchery to increase capacity at the hatchery while reducing our toll on the watershed. AGFC will leverage this funding with Federal Community Directed Federal Funds to complete the project.
- \$1,500,000 for Lake Conway to accelerate boat lane work to the summer of 2024 and aim for earlier project completion.

AGFC's completion of these projects will have a lasting impact on the conservation of the Natural State and provide hunting and fishing opportunities for generations to come.

Dear Secretary Hudson:

On behalf of the Department of Human Services (DHS), I respectfully request a release of Restricted Reserve Fund as set out in Section 3 (b)(8) of Act 561 of 2023 of the 94<sup>th</sup> General Assembly for the Division of Developmental Disabilities Services - Human Development Center (HDC) Master Plan Upgrade Set Aside.

DHS is requesting the release of restricted reserve set aside funds in the amount of \$8,000,000 to pay for the construction Phase I and a portion of Phase II of the master plan at Jonesboro Human Development Center (JHDC). Phase I of the JHDC master plan involves the construction of a health center/clinic to serve as an anchor building around which new beneficiary residences will be constructed as part of Phase II (as funding is available). It is anticipated that the \$8,000,000 in restricted reserve funding will cover the cost of constructing the new health center/clinic to complete Phase I, and then also the construction of one new residence as a start to Phase II. DHS will deposit the proceeds into a newly created paying account for tracking and reporting.
