DHS REALLOCATION OF RESOURCES REQUEST #3 OF 4 FY2024 March PEER

This is the third request by the Department of Human Services for Reallocation of Resources, from a limit of four annually. Section 11(c) of Act 492 of 2023 allows transfer authority to DHS and sets limits for the number of requests, dollar amounts of the total requests, and the purpose for which requests can be submitted.

This set of requests reflects the following impact to the allowances found in Section 11(c):

The following paragraphs outline the need for the transfers as requested by each Division.

SECRETARY'S OFFICE

The Secretary's Office (SO) is requesting to transfer 2 positions from the following divisions to better serve within the Office of Finance:

- 1 position from the Division of Medical Services; and
- 1 position from the Division of Youth Services.

The Secretary's Office is also requesting the following transfers within their Operations appropriation:

- \$100,000 from Regular Salaries to Extra Help to support increased Extra Help needs during the hiring freeze; and
- \$1,000,000 from Professional Fees and Services to Operating Expenses to support anticipated revenue transfers from the Arkansas Department of Education (ADE) for repayment of various expenses incurred on behalf of ADE following the passage of the LEARNS Act.

DIVISION OF CHILDREN AND FAMILY SERVICES

The Division of Children and Family Services (DCFS) is requesting the transfer of an Attorney position from the Division of Medical Services to assist in working caseloads.

DIVISION OF COUNTY OPERATIONS

The Division of County Operations (DCO) is requesting the following transfers within their Operations appropriation:

- \$1,000,000 from Personal Services Matching to Regular Salaries to cover increased salary expenses related to case management and SNAP appeal cases; and
- \$100,000 from Overtime to Extra Help for increased extra help needed to process case backlog and finger printing; and
- \$2,500,000 from Professional Fees and Services to Operating Expenses due to increased rent and utility costs and expenses related to the Summer EBT program; and
- \$1,700,000 from Professional Fees and Services to Data Processing Services to cover increased IT related expenses.

DIVISION OF DEVELOPMENTAL DISABILITIES SERVICES

The Division of Developmental Disabilities Services (DDS) is requesting to transfer \$2,817,041 in appropriation from Regular Salaries to Operating Expenses to align with the increased use of contract nurses and inflationary effects on food and drugs.

DIVISION OF YOUTH SERVICES

The Division of Youth Services (DYS) is requesting a transfer of one position from the Secretary's Office to enhance Alcohol and Prevention programs.

The Division of Youth Services is also requesting the following appropriation transfers:

- \$18,305 from Regular Salaries to Extra Help to help cover increased expenses related to education; and
- \$3,500,000 from the Community Services appropriation to Residential Services and Federal Child and Youth Service Grants due to an increased juvenile population in facilities.
