Dear Governor Hutchinson:

Reference is made to Act 1 of the 90th General Assembly's Third Extraordinary Session, the <u>Arkansas Highway Improvement Plan of 2016</u> (hereinafter called the Plan).

Section 13 of the Plan, Arkansas Code 19-6-832 (c) reads as follows:

In the event revenues to the department are insufficient to fully address the highway construction and maintenance needs of the state, the department may provide a written document to the Governor outlining the reasons that additional funding is needed and requesting that the Governor provide a recommendation to the Legislative Council or the Joint Budget Committee for review and approval of the transfer of funds in the Arkansas Highway Transfer Fund to the State Highway and Transportation Department Fund.

The Plan established the Arkansas Highway Transfer Fund which includes funding that can be utilized by the Arkansas Department of Transportation (ARDOT). A breakdown of the funding received in Federal Fiscal Year 2019 is as follows:

Transfer Source	Amount Received
Redirect the \$4 million of the Diesel Tax from General Revenue to the Highway Fund (70/30 split)	\$2,700,000.00
Eliminate the State Central Services Deduction from 1/2 cent sales tax	\$5,400,000.00
Securities Reserve Fund	\$20,000,000.00
Total Received	\$28,100,000.00

According to Act 1, ARDOT is now eligible to request 25% of the State Surplus that has been deposited into the Arkansas Highway Transfer Fund in the amount of \$73,851,004.84. A breakdown of the need for these funds is as follows:

Transfer Source – 25% of State Surplus	\$73,851,004.84
Fund Description	Amount Requested
Additional Needed for the Required State Match to Maximize the Use of Federal Fiscal Year 2019 Federal Funds	\$21,900,000.00
Expedite Repair of Recent Flood Damage	\$30,000,000.00
Expedite Pavement Preservation Projects	\$21,951,004.84

The Department respectfully requests your recommendation to the appropriate legislative body to transfer these funds from the Arkansas Highway Transfer Fund to the State Highway and Transportation Fund.

Thank you for your work to address our State's highway funding shortfall. I look forward to working with you to educate the public on the benefits of the long-term funding solution that will be presented to the voters in November 2020.
