The Arkansas Division of Workforce Services (ADWS) is requesting a cash appropriation for SFY 2020 in the amount of \$3,100,000 for fund 1670000 and fund center C31.

As you know, the Division of Workforce Services requested permission to deposit these funds, collected from stabilization tax proceeds, to allow ADWS to remove our obligations in 2 Capitol Mall so that we would be free to relocate our offices alongside the other agencies with the newly formed Department of Commerce.

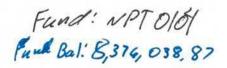

Dear Secretary Walther:

This letter is in regard to the operating expense budget for the Department of Labor and Licensing, Arkansas Appraiser Licensing and Certification Board (AALCB). We are asking for an increase in our operating expenses to adequately cover an additional pass-through fee the AALCB is required to collect and submit to the Appraisal Subcommittee (ASC) beginning in FY20.

Section 1473 of the Dodd-Frank Act included amendments to Title XI of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989. Section 1109 of Title XI was amended by the Dodd-Frank Act to require States that elect to register and supervise Appraisal Management Companies to collect a pass-through fee that is remitted in full to the ASC.

At the time the AALCB FY20 budget was completed, the Board was unsure of the amount of the fees. We are now requesting \$100,000 added to our appropriation to cover the pass-through fees. The fees will only be remitted to the Appraisal Subcommittee after collection from the Appraisal Management Company. Therefore, our revenue will increase by the exact amount as the fees remitted to the Appraisal Subcommittee.

Our cash balance in Treasury at the end of October 2019 was \$1,218,948. The Fund Center number is NAR0000 and the Commitment Item number is 5020002.

I hope this letter adequately explains our concerns. If you have any questions, please let me know.
