

For example, the previous system could generate a time when students were not in school because it was afterhours, the weekend or a holiday. The new system recognizes these events and only captures data when school is in session. Changes such as this, resulted in a forty percent increase to overall quarterly claims. Additional appropriation is needed as a result.
