On October 19, 2020 the Administrative Office of the Courts (AOC) submitted a Request Form for reimbursement through the CARES Act requesting \$149,647.51 (Funding and Restoration of Appropriation) in accordance with the Instructions for State Agencies issued by DFA. The Arkansas Division of Workforce Services (ADWS) is respectfully requesting Arkansas Legislative Council approval for an appropriation authorized under Section 36 of Act 2 of 2020, in the amount of \$46,000,000 for Fund TES0100 Fund Center 2SD for division operations. The request for commitments is below:

The Division has increased expenditures due to COVID-19, primarily related to increased staffing and IT contracts to modify the UI system for new CARES and Lost Wages requirements.

The Arkansas Division of Workforce Services hired 267 new employees, 149 fulltime and 118 extra help, during the time period of March 13, 2020, thru September 30, 2020. On March 12, 2020, DWS had a total of 667 filled fulltime positions and 121 filled extra help positions. As of September 30, 2020, the employee count stands at 816 fulltime staff and 239 extra help staff. This calculates into a 22 percent increase of onboard fulltime employees and a 98 percent increase of onboard extra help employees.

The additional appropriation for commitment item 501:00:06 is needed to continue to accommodate the employees working extra hours during the processing of exorbitant volumes of unemployment and fraudulent claims due to the COVID-19 Pandemic.

The increase of appropriation in commitment item 502:00:02 will be utilized to cover increased Protech and Maximus IT contracts for changes to the UI system required by the CARES Act and Lost Wages Presidential Declaration.

The increase for commitment item 506:00:10 is needed to continue to utilize the Contractor, MAXIMUS, to provide call center services and adjudication support allowing our adjudicators to focus exclusively on writing nonmonetary determinations. The total amount of the contract will be approximately \$10 million in total and the added appropriation will allow ADWS to continue to operate without interruption to meet the needs of the citizens of Arkansas.

Request for Temporary Appropriation Pursuant to Act 2 of 2020.

Dear Co Chairs:

The Department of Labor and Licensing requests approval from the Arkansas Legislative Council of a one-time, temporary appropriation in the amount of \$10,000.00 pursuant to Act 2 of 2020, section 34. This request for FY21 will provide the appropriation for two Extra Help (CI01) positions transferred to the department's Shared Services.

Specifically, the transfer will enable the department to provide help to various boards or programs and to charge the costs only for the hours utilized by the specific board or program. One position is for a hearing officer that will only be utilized upon request by a board. The other is to provide administrative support during periods of increased work, such as license renewal times. Again, the board or program will be charged only for hours requested and actually performed. For example, the hearing officer may serve in that capacity for two or three licensing boards in one month.

It is my understanding that this request requires the approval of the appropriation transfer by the PEER Subcommittee and the approval of the position transfers by the Personnel Subcommittee of the Arkansas Legislative Council.
